ORDER

Shri Sajal Kumar Roy, Jr. Engineer Irrigation & Waterways Directorate was suspended w.e.f. 13.05.2023 vide this Department order no. 1814-IW-17099/9/2023 dated 30.06.2023 in terms of sub-rule (3) of Rule 7 of the WBS (CC & A) Rules, 1971, due to his detention in police custody beyond 48 hours, in connection with the charges against him vide Alipurduar Women's Police Station Case No. 28/2023 dated 22.04.2023 u/s 498A/307 read with section (4) of DV Act.

Thereafter, Shri Sajal Kumar Roy has been honourably acquitted vide Judgement & order dated 09.09.2024 passed in S.C. Case No. 119 of 2024 & S.T. Case No. 29 of 2024 by the Ld. Session Judge, Alipurduar and also CR Case No. 375/2023 (Neoti Barman vs. Sajal Kumar Roy) has been disposed of after being withdrawn by the Petitioner vide Order dated 05.06.2024 by the Ld. Court of 3rd Judicial Magistrate, Alipurduar.

The Ld Legal Remebrancer has advised that the Administrative Department may proceed for withdrawal of suspension against Shri Sajal Kumar Roy, Jr. Engineer I&W Dte. after expiry of scope of appeal period of six months from the date of order of acquittal/dismissal as observed by Ld. Public Prosecutor, Alipurduar.

Such period of 6 months has got over w.e.f. 10.03.2025 since the passing of judgement of acquittal on 9.9.2024.

Now, therefore, the suspension vide order no. 1814-IW-17099/9/2023 dated 30.06.2023 issued against Shri Sajal Kumar Roy, Junior Engineer, Irrigation & Waterways Directorate is hereby revoked with immediate effect.

The period of suspension of Sri Sajal Kumar Roy shall be treated as a period "spent on duty" for all purposes and he shall be entitled to full pay and allowances to which he would have been entitled, had he not been suspended, prior to such suspension from the date of his resuming in duties.
