ORDER

Sri Dhiman Acharjee, Junior Engineer (Civil), presently posted under Teesta Canal Division No.I, Irrigation & Waterways Directorate, was appointed as **Nirman Sahayak** at Domohana Gram Panchayat under Karandighi Panchayat Samiti on **09/10/2007(F.N.)** vide Memo No. 1105/Panch/VI-65/2006, dated 07/10/2007 of Executive Officer, Uttar Dinajpur Zilla Parishad, Uttar Dinajpur in the scale of pay of Rs. 4500-9700/- of WBS (ROPA) Rules 1998.

Having been selected in the Sub-Assistant Engineers' Recruitment Examination, 2009-Civil Branch conducted by Public Service Commission, West Bengal and in pursuance of Memo No. 3803(87)-CIE dated- 28/12/2010 of Director of Personnel & Ex-Officio Chief Engineer, Irrigation and Waterways Directorate, **Sri Dhiman Acharjee** joined the post of Sub-Assistant Engineer (Civil) in Irrigation & Waterways Department on **30/12/2010(F.N.)** in the Pay Band of Rs. 9,000 - 40,500/- (PB-4) with Grade Pay Rs. 4,400/-, after being released from the post of Nirman Sahayak on **29/12/2010(A.N.)** vide Memo No. 36/Panch/VI-51(B)/07 Dated-17/01/2011 of Executive Officer, Uttar Dinajpur Zilla Parishad.

Now, the Governor has been pleased to accord approval regarding counting of past service of **Sri Dhiman Acharjee**, Junior Engineer(Civil), Irrigation & Waterways Department for the period **from 09/10/2007 (F.N.) to 29/12/2010 (A.N.)**, rendered as Nirman Sahayak, together with his present service towards pensionary benefit only, provided that, entries in the service book and verification of service is updated, in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) Dated: 27/05/2019 read with Rule 33(2) of D.C.R.B. Rules' 1971.

However, the previous service of **Sri Dhiman Acharjee** cannot be counted for seniority and MCAS benefit, for his present service, in West Bengal Engineering Services.
