All taxes Duties, Royalty and all other incidental charges shall have to be borne by the contractors.

Before submitting tender, the tender(s) are to satisfy themselves by actual visit the site as regard to 10.0 the condition of roads approaches and other condition of the locality and difficulties that may arise 11.0 during the execution of the work. Any Tenderer submitting tender shall be deemed to have done so .No subsequent claim on account will be entertained.
