## <u>NOTICE INVITING AUCTION NO. 01/S OF 2016-2017 OF</u> SUB-DIVISIONAL OFFICER, SINGUR IRRIGATION SUB DIVISION.

Sealed bids are invited by the Sub-Divisional Officer, Singur Irrigation Sub-Division from bonafied resourceful, experienced persons/ Agencies for "Dead and dry 5 nos. Sirish trees near ch. 1676 (R/B) of Kananadi, ch. 14.00 (R/B), Ch. 17.00 (L/B), Ch. 18.00 (L/B), ch. 19.00 (R/B) of Dy. No. N/5 near Khaserchalk Beltala, Gopalnagar, Khardaha in P.S. & Block-Singur, Dist.- Hooghly" as per annexed schedule (particulars) of trees (annexure -1). Necessary information and terms & conditions of auction sale are as laid down below:

- A. Intending auctioneers may apply in printed letter head paper to the undersignee up-to  $\underline{14.00}$  hours on  $\underline{02/06/2016}$  with attested photo (Xerox) copies of trade license as per W.B. Society act and municipality, PAN card, Latest income tax return and valid clearance certificate(s) of professional tax for obtaining prior permission for participating in the auction. Permission will be given to the eligible applicant(s) only which must have to be obtained before 14:00 hours on  $\underline{06/06/2016}$  from the undersigned.
- B. Intending auctioneers have to submit earnest money @ 2% (two percent) of the present market value i.e. Rs. 65,586.00 approved by Superintending Engineer, Damodar Irrigation Circle, in the shape of bank draft of any nationalized bank in favour of "Executive Engineer, Lower Damodar Irrigation Division" payable at Kolkata at the time of submission of bid. Earnest money of all unsuccessful auctioneers will be returned upon request after the issuance of work order to the successful auctioneer.
- C. Bids should be dropped in the tender box kept in the chamber of the undersigned within 14:00 Hours on  $\underline{09/06/2016}$  the same will be opened after 15:00 hours on  $\underline{09/06/2016}$  and sealed bid followed by open bid on  $\underline{09/06/2016}$  in presence of the participants of their authorized representatives who intend present at the time of opening.
- D. If due to some unavoidable circumstances, the office remains closed or declared holiday, the date(s) mentioned above will be substituted by the immediate next working day, the time and place remaining unaltered.

## **Terms and conditions:**

- 1. The auctioneers shall quote their bids in prescribed format both in figures & words and submit bids in sealed envelopes and shall be addressed to the Sub-Divisional Officer, Singur Irrigation Sub-Division with reference to the Auction notice. Bid quoted/ written in other than the specified space liable to cancellation.
- 2. Rates must be furnished for all trees (as per Annexure –I) only. No partial rates will be entertained.
- 3. The consignment will be sold to the highest bides with the discretion of the auctioning officer, if the rate found suitable. Sealed bid followed by open bid if necessary. The decision of the auctioning officer will be final and binding. The under-signee is not bound to accept the highest bid and reserve the right to cancel any or all bids without assigning any reason thereof.
- 4. The auctioned tree will be sold 'as is where & whatever is' basis. The dimension of the trees mentioned in annexure–I are approximate and are not guaranteed.
- 5. All intending auctioneer must inspect the site with prior communication and consultation with the Sub-Divisional Officer of Singur Irrigation Sub-Division or Sectional Officer, Singur Irrigation Section at Sub-Division Office from 12:00 p.m. to 4:00 p.m. of all working days and get full satisfaction about the particulars of the trees as per schedule (Annexure I). No objection or claim of any nature whatsoever will be entertained at the conclusion of the auction. Auctioneers have to furnish a certificate to the effect that they have inspected the site before submission of their offer.
- 6. The highest bidder will have to deposit the full amount of bid money within 7 (seven) days from the date of opening of the bid, failing which acceptance of his bid will automatically be cancelled/ rejected and the earnest money deposit will also be forfeited.
- 7. The successful bidder will arrange proper guarding the trees after issuance of work order from this end till lifting/ disposing off and clearance of site. The department will not be responsible for any loss or theft or damage may be caused as a result of fire/ flood or any reason of the auctioned/ sold tree.
- 8. The successful bidder will have to clear the site within the stipulated time of completion by cutting, lifting the trees and has to clear the site disposing off all debris deposited during cutting etc, to the full satisfaction of the engineer-in-charge.
- 9. The department/ under-signee reserves the right to cancel or postpone or recall the auction/ bid at any time without assigning any reason what so ever.
- 10. The successful bidder has to enter into an agreement with the department after depositing total bid amount to carry out the above work. He will be allowed to transport the same at his own cost after the formal agreement.
- 11. The time of completion of the work is 15 (fifteen) days from the issuance of the work order
- 12. The successful bidder should lift the identified tree only as mentioned in the Annexure- I.
- 13. The successful bidder will have to obtain necessary license/ permission/ transit pass etc. from the relevant department like Revenue etc. by depositing the prescribed fees for the purpose of transportation etc. and disposing off of the auctioned trees at his cost for which this Department will not

take any responsibility. The disposal including carriage shall be done as per local authority regulation at own cost of the bidder.

- 14. The successful bidder has to make his own arrangements viz. tools, plants & labour at his cost for cutting, transportation of trees including loading and unloading etc. and disposing off of the auctioned trees from site, within 15 (fifteen) days from the date of work order and he will not be allowed to cut/ transport the trees after expiry of the stipulated time.
- 15. The successful bidder should execute the work by taking necessary safety measures. He will be responsible for any damage to private or Government properties, and if any damage occurs he has to repair/ restore the same at his own cost or repairing/ restoration charges for such damage will borne by him as will be decided by the competent authority concerned. Any damages to the lives of human being/ animal etc. if causes for cutting, transportation of trees including loading and unloading etc. and disposing off of the auctioned trees, suitable compensation, as deemed fit, is to be paid by the successful bidder for such occurrence. The bid amount is exclusive of any/ all such compensation charge(s) of the damages of lives or property.
