TENDER NOTICE

Sub : *Notice inviting Tender in sealed cover for settlement of Government Fisheries in Block – Burdwan-I, Galsi-II, Jamalpur and Bhatar of the District Burdwan under Damodar Canal Division. (2 nd Call)*

Separate sealed tenders with respect to each water body are hereby invited from the Functional Primary Fishermen's Co-operative Societies and Fish production Groups and Self Help Groups as identified under Clause (b) and (c) of Sub-Rule-II for Burdwan District for settlement of the Government Fisheries (water bodies) as shown in Annexure A as per rule 272 (since amended) of West Bengal Land & Land Reforms Manual 1991.

For the purpose of the rule, for being eligible for taking part in the process of tender or auction :

- a) The primary Fishermen's Co-operative Societies, Fish production Groups and Self Help Groups shall mean having only active fishermen / women members, who take part in the fishery activities of the society / Group regularly for their livelihood and duly certified to this extent by the respective local Government and Fisheries Extension Officer of the local Block and countersigned by the Assistant Director of Fisheries of the Burdwan district.
- b) The functional Fishermen's Co-operative Society shall mean, having the management of the Society was satisfactory for the last three years in terms of fruitful utilization of the water body for optimal fish production and providing livelihood to the members in the opinion of the Assistant Director of Fisheries of the Burdwan District, besides fulfilling other statutory criteria as per law.
- c) Individuals / entrepreneurs shall mean any person or any organization having proper credentials in this regard duly accepted by the Committee constituted under Sub-rule (i) of Rule 272.

Any suppression or misrepresentation of fact will be liable for rejection.

Selection of beneficiary shall be made with due observance of the provisions contained in the financial rules embodied in the West Bengal Financial rules, Voume-1 and as amended from time to time.

Settlement of the each Government fishery shall be made in the form of lease to successful bidder for a period of 2 (two) years as per rule.

The successful tenderer will have to abide by rule 272 (since amended) of West Bengal Land & Land Reforms Manual 1991.

The successful tenderer will have to execute agreement in the office of the Executive Engineer, Damodar Canal Division within 15 days from the date of receipt of the intimation of acceptance of his tender.

Conditions of Lease :

- i. 25 percent of the rent for the first year's settlement shall be deposited at the time of settlement shall be deposited at the time of settlement and the balance shall be deposited before the beginning of the year. Rents for the successive years shall be deposited in full before the beginning of respective year. Failure to comply with any of the provisions of this sub-rule shall make the lease liable to be cancelled.
 - ii. The beneficiary with which lease is concluded shall make every effort to utilize the water area optimally. Failure to achieve minimum per hectare production as per norms to be fixed by Fisheries Department of the State Government for two consecutive years shall make the lease liable to be cancelled. The beneficiary with which lease is concluded shall submit the production return to the Executive Engineer, Damodar Canal Division at least 15 days prior to the beginning of the next year through Assistant Director of Fisheries of the Burdwan District.
 - iii. If during the lease period, it is reported / observed / found by the Assistant Director of Fisheries or by the District Land & Land Reforms Officer of the Burdwan district or by the Executive Engineer, Damodar Canal Division that the culture right of the water body has been transferred to any individual or other, directly or indirectly and the primary Fishermen's Co-operative Society / Fish Production Group / Self Help Group members have become passive and on inquiry by the Additional Director of Fisheries of the District the same is found to be true even by circumstantial evidence, shall also make the lease liable to be cancelled.
 - iv. In case where water of the Government Fishery is also used for other activities by the Government Department viz Agriculture / River Lift Irrigation etc., minimum threshold depth of average 5Ft water in the summer months for the better survival of the fish has to be kept. A monitoring committee, consisting of the collector of the District as the Chairman, the District Land & Land Reforms Officer, the competent authority viz. Agriculture / River Lift Irrigation of the respective district, as the case may be and the Assistant Director of Fisheries as the Convener of such committee shall monitor of this effect.
1. Last date of dropping of the of sealed tender in the sealed tender box to be kept at the office of the Executive Engineer, Damodar Canal Division upto **2.00 PM** on **22.07.2016** and sealed tender will be opened on the same day i.e. **22.07.2016** at **2.30 PM** in presence of the participants.
 2. The Bidder may obtain Bid proforma free of cost from the office of the undersigned during working hour up to **21/07/2016**.

3. The Bidder must quote the rate in prescribed proforma as attached with the notice. The amount quoted should be both in figure and word. The Bid proforma should be duly signed by the applicant.
4. The tenderer may submit tender in bid proforma in a sealed envelope and it should be dropped in tender Box.
5. Tender sent by ordinary / registered post or through e-mail shall not be accepted.
6. Sealed cover containing duly signed and bearing rubber stamp and complete in all respect along with necessary papers in support of eligible criteria mentioned earlier shall super scribe "Tender in connection with settlement of Government Fishery with serial no. of the water body as per Annexure-A".
7. The Superintending Engineer, Damodar Irrigation Circle shall confirm the accepted amount of bid and select the bidder. He may reject a tender without assigning any reason thereof.
8. The decision of the Superintending Engineer, Damodar Irrigation Circle regarding the acceptance and rejection of any or all tender shall be final and binding.
