2. PAN CARD, P.T.P.C. & VAT clearance certificate, should be submitted along with the quotation without which it will be treated informal.
3. Latest Income Tax return receipt certificate.
4. The bidders are bound by the terms and conditions of WBF no - 2911(i/ii) along with the specification, notice of quotation along with all enclosures, Special Terms & Conditions, if any, and schedule of works etc. which forms part and parcel of the contract. No extra claim whatsoever shall be admissible afterwards.
5. No conditional Bid/Offer/Proposal shall be accepted and deemed as 'Informal'.
6. Payment shall be made on monthly basis after having given satisfactory service for the month subject to availability of fund. In case of delayed payment, no extra claim can be made.
7. **The Period of contract for execution of the work is for 12 (twelve) Months from the date as mentioned in the work order, but the contract may be terminated at any point of time in the event of mal-performance of the agency. The period of contract may be extended as required by the Engineer-in-charge, during which period the rate would remain unchanged.**
