- E) Trade license etc. in original along with the application for bid papers (Xerox self attested copy of the same must be attached).

2. Last date and time limit for issuing of Bid papers is 28.02.2017 upto 4.00 P.M.
3. Last date and time limit for receive of Bid Papers is 02.03.2017 upto 4.00 P.m. with sealed envelope which must be dropped in the quotation box kept in the chamber of the Sub - Divisional Officer, Baruipur Drainage Sub - Division and will be opened on the same day at 4.00 P.M.
4. The auctioneers willing to participate are required to submit Bank draft/Pay order/Banker's Cheque of total auction money as bid offer in favour of the **Executive Engineer, Mograhat Drainage Division** otherwise the bid will be treated as informal and offer will be rejected.
5. **A security deposit of 10 % of bid value/purchase money** shall have to be deposited in addition to the bid amount along with bid in the form of Bank draft/Pay order/Banker's Cheque in favour of **Executive Engineer, Mograhat Drainage Division**, otherwise the bid will be treated as informal an offer will be rejected.
6. No bid papers will be accepted after the specific time and date.
7. Auction materials have to be removed within 7 (Seven) days from the date of lifting order otherwise the security deposit shall be forfeited without issuing any further notice.
8. Any damage or loss of Public Property will be sole responsibility of the bidder.
