 - b) Submission of Tenders by Post or FAX or through Internet is not allowed.
- The Tender Document and other relevant Particulars (if any) may be seen by the intending Tenderers or by their duly 5) authorized representative during office hours between 11.00 A.M. And 4.00 P.M. on every working day, till the date of issue of tender papers in the office of the Sub-Divisional Officer, Teesta Barrage Electrical Sub-Division-III, , Karnajora, Uttar Dinajpur. Any tenderer may send his authorized representative to attend interview, bid or any other purpose allowed by tender accepting authority. Such authorization must be submitted in stamped paper in presence of 1st class Judicial Magistrate or Notary Public.
- 6) a) Intending Tenderers should apply for Tender Papers in their respective Letter Heads enclosing self attested copies of P.A.N. / V.A.T Registration & P.T. Clearance Certificates and Completion Certificate, and Work order with Work Schedule Documents for similar nature of single completed Work.
 - b) Applicants are required to produce, on demand as well as during the interview (if any), the originals of the following Documents.
 - i. P.A.N., V.A.T Registration & P.T. Clearance Certificates valid at least up to the date of opening of the Tenders.
 - Completion Certificates for similar nature of single work worth at least 30% of the value of the Work for which Tender ii. Paper is desired, executed within last 5 (five) years from the actual year of completion.
 - iii. Eligibility Certificate issued by the A.R.C.S. (for Engineers' Co- operatives and Labour Co-operatives.)
 - Partnership Deed (for Partnership Firms) and Registration from the Registrar of firms. iv.
