1. Eligibility criteria to participate in the quotation:

A) The agency/ contractor willing to participate in the quotation, shall have to apply in their own printed letter head pad containing full mailing address with working phone no along with all relevant documents.

B) The application shall have to be made by the intending agency/contractor himself/herself or by his/her authorized representative.

C) Intending agency/contractors will have to produce set(non refundable) of photocopy with self attestation by full signature of Pan card, Professional Tax Challan, SARAL (ITR) which will be valid up to the date of opening of tender at the time of application, otherwise no quotation paper will be issued.

D) By law, pan card, professional tax clearance certificate, one set(non refundable) of photocopy with self attestation by full signature for Unemployed Engineer's Co-operative, Labour Co- Operative, valid up to the date of opening of tender at the time of application, otherwise no tender paper will be issued.

E) As the items to be procured by the undersigned are of Godrej make, hence authentic authorisation certificate from Godrej Co. has to be furnished as supporting document.

2. Paper will be issued only to those bidders/agencies/contractors who will be eligible after scrutiny by the quotation accepting authority.
