In additional terms and Condition of the above e N.I.T No. WBIW/EE/MNCD/e-NIT-04(e) /2017-18 against 2nd call of WBIW/EE/MNCD/e-NIT-02(e) /2017-18.

1) Strict adherence regarding GST should be done as per no. 4374-F(Y) Dated 13/07/2017 of Finance Department , Audit Branch, Government of West Bengal, **VALID DOCUMENT OF GSTIN MUST BE UPLOADED** in the certificate folder in pdf.

2)The following clause has been include as clause no.28:-

The “Additional Performance Security” to be deposited by the successful L1 bidder, if the accepted bid value is below 20% of the estimated amount put to tender.

This Additional Performance Security shall be equal to 10% of the tendered amount i.e. the L1 bid price. The Additional Performance Security shall have to be submitted by the selected bidder after issuance of Letter of Acceptance / Letter of Invitation (LoA / LoI) and before Award of Contract (AoC) in the form of “Bank Guarantee” of any schedule Bank, payable at Rampurhat or / in West Bengal, as per enclosed format (Annexure). If the bidder fails to submit the Additional Performance Security within the seven working days from the date of issuance of LoA / LoI, its Earnest Money Deposit (EMD) will be summarily forfeited.

The said Bank Guarantee (BG) shall have to be valid up till the end of the Contract-Agreement period including extended time period till 100% physical completion of work in all respects and shall be renewed accordingly if required. The said Bank Guarantee shall remain in custody of the DDO & Executive Engineer in-charge of the work, which shall be return to the bidder/ contractor immediately after successful physical completion of the work as per contract.

If the bidder fails to complete the work successfully, this Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving suitable notice to the contractor / bidder agency.

The all other terms and conditions in original tender will remain unchanged.
