## Terms and condition of Auction Sales

1. It shall be deemed that all bidders have thoroughly read and understood the terms and conditions of the notice before bidding. It will also be deemed that all the bidders have inspected the properties prior to quoting rate and have satisfied themselves with the full particulars of the same. No objection or claim of any nature whatever shall be entertained at the conclusion of the auction.
2. Each intending bidder shall have to deposit the earnest money through Bank draft/ pay order in favour of the Executive Engineer, Kangsabati canals Division no-II(I&WD), Government of West Bengal otherwise the bid will be treated as informal and offer will be rejected.
3. The bidder of auction sale shall quote his bid in prescribed format obtained from this office and submit bid in sealed envelope and shall be addressed to the Sub-Divisional Officer, K.C.Sub-Division No-VIII, Raipur,(I & WD), Government of West Bengal. The earnest money of successful bidder will be released after completion of lifting of auctioned materials within the schedule date of completion of the work.

Money shall be forfeited in the following cases:

- a. If the Bidder withdraws his bid during the period of bid validity.
  - b. If the successful bidder fails to deposit full bid price within the stipulated time after issuance of acceptance letter.
  - c. In case of failure on the part of the bidder to cut and/or lift trees within the stipulated period.
4. The bidders shall quote their bid price both in figures and in words in prescribed format issued to them from this office against application. All bidders must inspect the trees, which are marked at site, thoroughly before quoting their rates on any working day in consultation with the Sub-Divisional Officer, K.C.Sub-Division No-VIII, Raipur.
  5. **Bid less than the Reserve Price will not be accepted.**
  6. If the highest bid in the opening of the undersigned does not appear to be satisfactory the undersigned reserves the right of holding fresh bid and so on.
  7. Each bidder or his authorized representative shall have to remain present at the time of opening the bid so that table, bid may be held if required immediately after opening the bid.
  8. Cutting / lifting of auctioned materials:
    - a. The successful bidder will have to clear the site at his own cost by lifting the trees within **10 (Ten) days** after receiving lifting order from the department with due satisfaction of the Sub-Divisional Officer, K.C. Sub-Division No-VIII,(I & WD) Raipur.
    - b. The successful bidder will have to obtain transit pass after depositing fees prescribed for the purpose from the Divisional Forest Officer, Bankura Division whichever is applicable for lifting of the materials.
    - c. The successful bidder, during cutting/disposal of trees will have to arrange for any blockage/temporary opening of Electric supply line inside or outside the Premises through the W.B.S.E.D.C.L authority and all cost in this matter to be borne by the successful bidder at his own cost.
  9. The intending bidder will have to write his name, address and telephone number clearly on the bid paper.
  10. The intending bidder needs to apply and quote his single rate for entire list of materials.
  11. The Executive Engineer, Kangsabati canals Division no-II, (I&WD), Government of West Bengal reserves the right of withdrawal of auction sale and may reject any or all the bids without assigning any reason whatsoever.
  12. The undersigned reserves the right to reject any or all the bids without assigning any reason.
