Executive Engineer Joynagar Irrigation Division Irrigation & Waterways Directorate SPECIAL TERMS & CONDITONS FOR "SELLING OF STANDING CROPS OF COCONUT TREES AND OTHER TREES AT RAIDIGHI IRRIGATION CAMPUS OUTSIDE THE QUARTER PREMISES UNDER RAIDIGHI IRRIGATION SUB-DIVISION OF JOYNAGAR IRRIGATION DIVISION FOR THE PERIOD OF THREE (3) YEARS."

- 1. The agency shall be responsible for guarding & nourishment of the trees including supply of manners, spraying insecticides etc. at his/ their own cost for maintaining the healthy / luxuriant growth of the living plants. After selling of crops/coconut at each time plants to be made cleaning near the fruit growing zone for non obstructed growth and more effective fruit productivity by expertise person.
- 2. The agency would be entitled to sale the fruits/ or dry leaves of the coconut trees & other trees only but care should be taken that trees are not damaged in any way.
- 3. The agency will be responsible for any damages to the trees caused due to his / their negligence. The penalty of Rs. 250/- (Rupees Two Hundred & Fifty) only per damaged tree will be charged & would be realised from the agency.
- 4. Any unlawful activities of the Government Land at Raidighi Irrigation Campus should be immediately stopped & reported by the agency. He should be held responsible for any negligence in this regard on his part.
- 5. The agency may have the liberty of cultivation of the new coconut plantation subject to prior approval of the Engineer in-charge for which he / they will not be entertained any expenditure incurring for this purpose.
- 6. The period of maintenance & guarding for 3 (Three ) years but for any reasons whatsoever both the parties shall have the liberty to terminate / revoke the agreement after serving the written prior notice at least for one calendar month effecting from 1st day of such month.
- 7. The agency will have to pay the annual rent to the Government of West Bengal within 1 month of the calendar year for which such rent shall be payable .The agency may keep chowkider or watchman to guard the coconut plantation & for that purpose he/ they may erect temporary structures (erection an number of such temporary structures have got to be approved in writing) which should be demolished at his / their own cost of the expiry of such contract period.
- 8. The Engineer-in-charge (i.e. Executive Engineer, Joynagar Irrigation Division) reserve the right of rejecting any or all the quotation without assigning any person whatsoever. It may please be noted that in case of any dispute of any matter arising out of the agreement decision of the Engineer-in-charge (i.e. Executive Engineer, Joynagar Irrigation Division) shall be final & binding.
- 9. The Department will have no obligation for supply water for plantation and maintenance & nourishment of coconut trees. The agency will have to make his /their own arrangement for which no cost will however be entertained by the Department.
- 10. A) The agency should ensure that the Raidighi Irrigation Campus is always kept free of any debris etc. from coconut trees and other trees and he should dispose of all debris/waste out of the irrigation Campus at his own cost.
  - B) The entire Campus should be kept clean all around for the said period.

11. The successful qoutationer / agency shall have to deposit an amount <u>@2.00% of the total quoted amount</u> as **earnest money** in the form of Bank Draft / Demand Pay in favour of the Engineer incharge (i.e. Executive Engineer, Joynagar Irrigation Division) <u>at the time of Formal Agreement</u> which will be refunded after successful completion of the contract or termination of the contract whichever is earlier, if the situation so demands in the exigency of the Public Service.
