- **13.** The Tenderer should submit a statement at the time of submission of his tender showing the Technical Staff to be maintained for the work, with their technical qualifications, failing which the tender may be liable to rejection.
- **14.** Conditional Tender, which does not fulfill any of the above condition, and is incomplete in any respect, is liable to summarily rejection.
- 15. In view of introduction of GST with effect from 01.07.2017, all the bidders intending to participate in this tender should offer their bids inclusive of GST applicable for entire composite works/Procurement of goods & services, labour intensive component etc. No separate payment towards GST shall be made by the Tendering / implementing authority. The estimated amount put to tender in the instant Tender is not inclusive of GST component but contains the pre-GST taxation amounts.
