 - 4. a. Intending Tenderers should apply for Tender papers in their respective Letter Heads enclosing self attested copies of the following documents, original of which and documents like Registered Partnership (for Partnership farms) etc. are to be produced on demand, as well as during interview (if any).

- **c.** Any suppression/misrepresentation of fact will automatically debar the applicant from participating in any tender under the Division/ Circle for at least 3 (Three) years from the date of detection, in addition to such other Penal action as the Government may deem proper.

- 11. The Tenderer who will sign on behalf of a Company or Firm must produce the registered documents (within 3 days from the date of opening the Tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act. Failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- **12.** Any Letter or other instrument submitted separately in modification of the sealed tender may not be entertained.
- **13.** The Tenderer should submit a statement at the time of submission of his tender showing the Technical Staff to be maintained for the work, with their technical qualifications, failing which the tender may be liable to rejection.
- **14.** Conditional Tender, which does not fulfill any of the above condition, and is incomplete in any respect, is liable to summarily rejection.
- 15. In view of introduction of GST with effect from 01.07.2017, all the bidders intending to participate in this tender should offer their bids inclusive of GST applicable for entire composite works/Procurement of goods & services, labour intensive component etc. No separate payment towards GST shall be made by the Tendering / implementing authority. The estimated amount put to tender in the instant Tender is not inclusive of GST component but contains the pre-GST taxation amounts. GST (CGST, SGST, IGST), Royalty, Building & other Construction Workers Cess and all other statutory Levy/ Cess etc. will have to be borne by the Contractor (he will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work). - **18.** The Tender will be opened as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives who may be present at time of opening and who may also put their signatures in the Tender Opening Register.
- **19.** The successful Tenderer will have to execute the duplicate copies of his tender which will have to be obtained in the office of the **Executive Engineer, Joynagar Irrigation Division**, within 7 (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest money shall forthwith stand forfeited in favour of the Government and the Communication of acceptance of the tender shall automatically stand cancelled.

- 20. If any Tenderer withdraws his tender before its acceptance or refuses / fails to convert it into a reason contract within a reasonable time, without giving any satisfactory explanation for such withdrawal/ refusal / failure he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- **21.** The successful Tenderer will have to abide by the provisions of the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972 and such other Acts as may be applicable as will be force from time to time.
- 22. Materials such as Cement M.S. Rod, R.C.C, hume Pipes, M.S. Sheet Piles etc. if available in stock, will be issued by the Department to the Contractor for the work as per Issue Rate fixed by the Engineer-In-Charge. Site of issue of materials as mentioned in the list of Materials to be supplied Departmentally to the Contractor is furnished with the tender documents for the work.
