GENERAL TERMS AND CONDITIONS

- 1) The intending quotationers will have to apply in their own letter head/pad to the undersigned for permission to participate in the said quotation within stipulated time/date. The quotationers should produce (original) and enclosed with application (photo copies) of the valid current Income Tax (ITR, etc.), Professional Tax Clearance Certificate, PAN Card, GST Identification Number (GSTIN) Documents (as applicable) and credentials of supply/works of similar type of items.
- 2) The intending participant should be thoroughly acquainted themselves with the proposed works, site/electrical wiring condition of the building etc. by local inspection of the site etc. and he should take into consideration the difficulties likely to be involved in the execution of work or delivery of the material on the above address.
- 3) Details specification including schedule of work/supply may be had from the office of the undersigned during the office hour or any working day between 11 a.m. to 4 p.m.
- 4) Rate should be quoted as per Serial Number of the schedule.
- 5) After obtaining quotation paper/schedule in complete set, the participants have to quote their rates both in figure & in words inclusive of all taxes & other incidental expenditure if any in that printed form in the space provided for the purpose.

- 7) Departure of any terms & condition or inclusion of any additional conditions will cause the quotation as "Informal".

- 9) Any kind of advance payment whatsoever will not be entertained and payment will be made through treasury as per availability of fund.
- 10) In case of any dispute arise the contract may be terminated by the undersigned with one week notice to the supplier.

He must execute a formal agreement with the **Executive Engineer, Teesta Mechanical Division/ Assistant Engineer, Teesta Mechanical Sub-Division-II** in WBF 2911(ii) printed form within 07 (Seven) days from the date of receipt of acceptance letter.
- 14) The successful Quotationers will be required a sum to be deposited @ 2.00% (Two point zero zero percent) of the total value of the quoted rate in the form of the original copies of the Demand Draft/Banker's Cheque of Nationalised Bank guaranteed by the Reserve Bank of India in favour of the **Executive Engineer, Teesta Mechanical Division, Fulbari, Jalpaiguri**.
- 15) Goods will be delivered free at consignee's end, including freight, forwarding and under standard transit insurance clause that the purchaser will not pay separately for the insurance charges and it will be the supplier's responsibility for the safe arrival of goods in full and good condition.


