The following changes have been made in the said e-NIT No. WBIW/SE/DIC/NIT-05(e)/2018-19 (2nd Call), SL. NO.1, Tender Id.- 2018_IWD_184692_1.

1. In page no. 3 of 37 the Column 8 of List of Works is replaced by the following column.

Minimum eligibility criteria to match the Prequalification (PQ) works credential in terms of execution of similar previous works contract (*)

Summary of minimum eligibility requirements for technically qualifying for next part of financial bidding of this e-Tender:

A. Technical PQ Credential:

- i. The bidder must have satisfactorily completed at least 1 (one) work of 'similar in nature' in dams/barrages/similar hydraulic structures under Government Sector within last five FYs on the date of publication of this e-NIT of Gross monitory value not less than of Rs. 22,30,15,192.00 (not less than of Rs. 44,60,30,384.00 for Consortium/Joint Venture) (Gross monitory value is calculated based on gross final billed value given in Credential Certificate (CC) multiplied by inflationary factor, executed within preceding five FYs of similar nature not be less than 25% of the amount put to tender of the work for which the bidder chooses to participate in this NIT. The same shall be minimum 50% for Consortium/Joint Venture).
- ii. Pre-Qualification criteria of 'similar in nature' will be established, if summation of monitory values of Concrete items (PCC/RCC/PSC/Cementitious Grouting) forming the Major Item of this work, as derived from the BOQ of the instant work tendered in this e-NIT, when multiplied by 0.35, the resultant monitory value is less than or equal to the monetary value of Concrete items (PCC/RCC/PSC/Cementitious Grouting) of the BOQ submitted in the bid as PQ work credential multiplied by the inflationary factor as stated at Clause 7.l.(a). (The same shall be minimum 0.70 for Consortium/Joint Venture).

- Major Item description in brief: Concrete items (PCC/RCC/PSC/Cementitious Grouting).
- b. PQ work credential multiplied by the inflationary factor for above Major Items should not be less than Rs. 11,48,32,646.00 (The same shall be Rs. 22,96,65,292.00 for Consortium/Joint Venture).
- iii. The bidder must have conducted under water investigation of similar structure and also must have conducted grouting (cementitious/other materials), preferably in under water conditions, in the same work where under water investigation was conducted. Credential/activities stated in this para should preferably be part of the work stated to be of similar nature, as detailed in [A.i.] & [A.ii.] above.

B. Financial eligibility as PQ Credential in preceding three FY:

- a) Average of Gross Annual Turnover of the bidder except for Consortiums and Joint Ventures for any three FYswithin immediate preceding five FYs on the date of publishing of NIT as stated in clause 7 V. should be at least Rs. 35,68,24,307.00.
- b) The above value for Consortiums or Joint Ventures should be at least Rs. 71,36,48,614.00 (Turnover of each Partner of Consortium/Joint Venture should be **Rs. 7,13,64,861.00**).
- c) Bidder's Net worth in any three preceding FYs within the zone of preceding five FYs should be positive (determined from Audited Profit & Loss Accounts and corresponding audited balance sheets stated in Clause 7 V.c.
- (Both A & B stated above should be simultaneously fulfilled as minimum PQ eligibility for qualifying in the TechnicalBid Evaluation stage for final selection in financial bid stage based on quoted bid price, and all claims for eligibilityare to be substantiated with valid legally authentic documents during submission of on-line bid itself).
- (*) For Consortium and Joint Venture, additional criteria mentioned under Cl. 1 (Note), 4.2 B (II) & Cl. 7 V of the General Terms & Conditions in this e-NIT may be referred.

iii. List of Essential Laboratory Equipment for aggregate and concrete testing in the laboratory to be installed at site to ensure quality of material/concrete should be mentioned by the Bidder.

iv. List of essential plant and machinery like batching plant, transit mixer, concrete pump, crane, dumper, hydra etc. in possession of the Bidder should be mentioned.

5. In page no. 9 of 37 after clause no. 5. iii. the following additional para is inserted as clause no. 5. iv.

5.iv. Security Deposit or Performance Security

The entire Security Deposit or the Performance Security may be released after physical and financial completion of the project but before expiry of the security period or defect liability period against receipt of equivalent amount of bank guarantee of approved bank of RBI which should remained valid till the expiry of the defect liability period.

6. In page no. 15 of 37 under clause 14.4 the following additional para is inserted.

Power is delegated to HTEC to verify the authenticity of bid documents by physically summoning the applicant bidder on the basis of specific doubts which could not be cleared, in extreme cases, which shall be exercised only when all other methods of undertaking verification have been exhausted, and there is ample reason to believe that fairness of the technical bid evaluation of the tender cannot be ensure without such action. Prima-facie, there is not enough reason to doubt the authenticity of the bid documents, physical summon of the bidder may be avoided, as after determination of L1 bid in financial bidding and before issuance of LOA, all the on-line documents would be verified with the original by the Accounts and Estimating branches of the office of the designated Executive Engineer, and reported to the Tender Accepting Authority prior to issuance of LOA.
