NOTICE INVITING TENDER NO -08 OF 2018- 2019 OF EE/BDD.

1. Separate sealed Tender in printed form are invited by the Executive Engineer, Bidyadhari Drainage Division on behalf of the Governor of West Bengal for the works as per list attached herewith, Bonafide reliable and resourceful Contractors having sufficient experience in execution of similar type of works as per categorization, detailed herein under.
2. a) Separate Tender should be submitted for each work, as per attached List in sealed cover super scribing the name of the work on the envelope and addressed to the proper authority.
b) Submission of Tender by Post is not allowed.
3. The Tender documents and other relevant particulars (if any) may be seen by the intending Tenderers or by their duly authorized representatives during office hours between 11.00 AM and 4.00 PM on every working day, till (before application date) **11.09.18**. In the Office of the Executive Engineer, Bidyadhari Drainage Division .
4. a) The intending tenderers may submit their application in the office of the Executive Engineer, Bidyadhari Drainage division, Taki Road, Barasat, North 24 Parganas. The application shall be addressed to the Executive Engineer, Bidyadhari Drainage division, Taki Road, Barasat.
Intending Tenderers should apply for Tender Papers in their respective Letter Heads enclosing self-attested copies of the following documents, **originals of which and other documents like Registered Partnership (for Partnership Firms) etc. are to be produced on demand**, as well as during interview (if any) .
 - i) PTPC, Trade Licence and IT, PAN valid up to the date of opening of the Tenders. Application for such clearance addressed to the competent authority, subject to production of authenticated receipt may also be considered.
 - ii) Completion Certificates / Payment Certificate(s) for one single similar work worth at least **30%** of the value of the work for which Tender Paper is desired, executed within last than **5 (Five)** years (to be determined from the actual year of completion, considering current financial year as Year - 1).

13. **Note:** For cases where two contractors/bidders are participating in a Tender for a particular work are such that one happens to have worked as a sub-contractor of the other, and both the contractors/bidders PQ submit work credential of having completed the same job either wholly or partly, then in such case the PQ credential of the principal contractor will be considered while that of the sub-contractor will not be taken into consideration for determining the eligibility criteria of the contractor/bidder during technical evaluation of the tender. If the PQ Credentials submitted by hitherto contractors/bidders are for different works, then both the PQ Credentials will be considered for determining the eligibility criteria of the individual contractors/bidders.
14. Tender should be dropped as mentioned below :
- a) Executive Engineer, Bidyadhari Drainage Division, Bidyadhari Bhawan, Taki Road, Barasat, (Kolkata-124).
15. When a Tenderer signs his Tender in an Indian Language, the total amount tendered should also be written in the same language. In the case of illiterate Tenderer, the rates tendered should be attested by an witness .
16. The Tenderer who will sign on behalf of a Company or Firm, must produce the registered documents (within 3 days from the date of opening the tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act, failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
17. Any letter or other instrument submitted separately in modification of the sealed tender may not be entertained.
18. The Tenderer should submit a statement at the time of submission of his tender showing the Technical Staff to be maintained for the work , with their technical qualifications, failing which the tender may be liable to rejection.
19. Conditional Tender, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to summary rejection.
- Income Tax, Sales Tax, Royalty, Construction Workers' Welfare Cess and similar other statutory levy / Cess will have to be borne by the contractor/bidder and his/her quoted rate should be quoted accordingly after considering all these charges. Only Service tax, as applicable, if eligible, would be reimbursed as per rules on production of necessary documents.

Valid PAN issued by the IT Deptt. Govt of India.

Valid 15-Digit Goods and Service Taxpayer Identification Number (GSTIN) under GST Act , 2017.(Photo Copy of Downloaded GSTIN)

(Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act 2017.) (However necessary modifications will be made on implementation of GST rules).

21. VAT, Royalty, Building & other Construction Workers' Cess and all other statutory Levy / Cess etc. will have to be borne by the Contractor (he will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work) .

It may further be noted that if VAT Registration Certificate is produced before receiving payment, It will be as per present Government Order or as may be notified by the Finance Department from time to time will be made, otherwise such deduction shall be as per present norms, or as may be prescribed by the Finance department.

22. The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without assigning any reason whatsoever to the intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers.

23. The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him .

24. Tender shall be opened by the Executive Engineer, or his authorized representative as per stipulation of the Notice Inviting Tender or any corrigendum issued later on the schedule date and time.
The Tenders will be opened, as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives, who may be present at the time of opening and who may also put their signatures in the Tender Opening Register.

25. The successful Tenderer will have to execute the duplicate / triplicate copies of his tender after purchasing the same from the office of the Executive Engineer, Bidyadhari Drainage Division, within 7 (seven) days from the date of receipt of the intimation of acceptance of his tender.

26. If any Tenderer withdraws his tender before its acceptance or refuse / fails to convert it into a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal / refusal / failure , he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.

27. The successful Tenderer will have to abide by the provisions of the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972 and such other Acts as may be applicable, as will be in force from time to time .

28. Materials such as Cement, M.S. Rod, R.C.C. Hume pipes, M.S. Sheet Piles etc. if available in stock, will be issued by the Department to the Contractor for the work as per Issue Rate fixed by the Engineer-in-Charge. Site of issue of materials as mentioned in the list of materials to be supplied Departmentally to the Contractor is furnished with the tender documents for the work . Any other materials not listed therein, if supplied by the Department, the Issue Rate for such materials will be fixed by the Engineer-in-Charge.



29. All materials brought to the site must be approved by the Engineer-in-Charge. Rejected materials must be removed from site within 24 hours of the order issued by the Engineer-in-Charge.

30. Hire charges for Tools & Plants Machinery, if issued Departmentally, will be recovered from the Contractor at such rates as will be fixed by the Engineer-in Charge. The period of hire charges of all Tools & Plants Machinery issued from the Government godown will be counted from the date of their issuance from the Godown and up to the date of return into the same godown and the hire charges will be recovered from the Contractor accordingly. All Tools & Plants Machinery issued to the Contractor must be returned in good condition. In the case of any damage, the cost of repair to such damage or replacement will be recovered from Contractor.
31. In the following cases a tender may be declared informal and unacceptable .
 - a) Correction, alterations, additions etc. if not attested by the Tenderer.
Earnest Money in the form of T.R. Challan, D.C.R. / Demand Draft etc. which are short deposited and/or not deposited in favour of the Executive Engineer, Bidyadhari Drainage Division.
 - b) If the Tender form is not properly filled in respect of the general description of the work, Estimated Cost, Rate of deduction of Security Deposit, etc. in page-2 and other pages as are required to be filled in.
 - c) If the specified pages of the Tender Document are not signed by the Tenderer.
 - d) If the Tender is not submitted in a Cover properly sealed and the name of the work is not indicated on the cover.
32. For the return of the Earnest Money of the unsuccessful Tenderer(s), he / they is / are to apply for the same to the Executive Engineer, Bidyadhari Drainage Division, giving the reference to the work, N.I.T. No., date of tender, amount and mode of Earnest Money deposited – all in a complete form. The Earnest Money of all Tenderers other than the lowest Tenderer in each case, may be refunded, after acceptance of the rate in the comparative statement, as early as possible.
33. To verify the competency, capacity and financial stability of the Intending Tenderer(s) the Tender Paper Issuing Authority may demand production of any necessary document(s) as it may deem necessary.
34. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort the canvassing will be liable to rejection.
35. The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due to delay in payment will be entertained.
36. As per G.O. No.1027(8)/1A dated 26th. November 2001 of Irrigation & Waterways Department, Government of West Bengal, Clause 25 of Tender Form No.2911 stands deleted in respect of contract of value less than Rs.100.00 lakh.
37. Additional Terms and conditions of contract and specification for works to form part of the contract shall conform to the schedule of rates of Greater Calcutta Drainage Circle, Public Works Department /Public Works (Roads) Department .
38. Normally, Tender Paper for not more than one work in any one NIT will be issued to an applicant, who may indicate the S. Nos. of the work in the order of priority opting for at least two Sl. Nos. where possible. However, depending on response to various serials in the NIT, Tender Paper Issuing Authority may issue Tender Paper for any serial even though it may not be preferred by the applicant.

Categorization of Works :

1. Earthwork : Earthwork in excavation / filling for embankment, canal, drainage Channels executed under Irrigation & Waterways Department .
2. Protection Works : All kinds of river / channel bank / embankment protection works (with boulder, CC blocks, revetment works, sausages, brick blocks, dry brick pitching, etc.)
3. Lining Work : All kinds of water face lining / brick block pitching / dry brick pitching, in Irrigation canal / drainage channels etc.
4. Hydraulic Structures : Aqueducts, Regulators, Syphons, Bridges across Waterways, Sluices, Dams, Barrages etc.
5. M.S. Structural Works etc. : Gates of all kinds, electrical installations, pumps and allied machinery .

The above list is only indicative and not exhaustive.


