<u>ORDER</u>

In order to encourage more bidders to participate in high value e-tender process including Engineering Procurement & Construction (EPC) Projects:

- 1. The quantum of Earnest Money Deposit has been revised as 2% of the amount put to tender or Rs. 50 lakh, whichever is lower.
- 2. The entire Security Deposit or the Performance Security may be released after physical and financial completion of the project but before expiry of the security period or defect liability period against receipt of equivalent amount of bank guarantee of approved bank of RBI which should remained valid till the expiry of the defect liability period.
- 3. In case of mobilisation advance, permission is hereby accorded for allowing mobilisation advance in favour of the selected agency in deserving cases maximum up to 10% of the tendered amount subject to recovery of the same along with 10% simple interest in maximum 5 instalments commencing from the 1st RA Bill.

This order issues with the approval of Finance (Audit) Department, Group-T vide their U.O No. Group-T/2018-2019/0149 dated 15.05.2018.

This Departments' Order No. 15(8)-Pr. Secy I&W/2016 dated 11.07.2016 relating to West Bengal Form No. 2911, Memo No. 14(8)-IB dated 09.04.2018 relating to latest standard e-NIT, and Memorandum No. 32-(W)/2016-17 dated 16.11.2016 relating to EPC Contract stands modified to that extent.
