The following corrections have been made in the Notice Inviting e-Tender No. - WBIW/SE/EC/NIT-16(e)/2018-19, on regarding "e-NIT", "TERMS OF REFERENCE" and "SPECIAL TERMS & CONDITIONS OF CONTRACT(SCC)" are given below:

**1. In "e-NIT" Clause 2.1 Note:**

**will be read as**

"In case of a Consortium or Joint Venture, the maximum number of constituents shall be restricted up to 3 (Three), all should be bonafide Indian entities as stated above and each of the constituents must have at least 10% of tender value as their individual average of annual turnovers from business in any three financial years within the zone of last five financial years and also fulfilling other PQ criteria. Individual constituents of a Consortium or JV cannot form another Consortium or JV to bid in the same work of the e-NIT. Where ever a JV/Consortium has submitted a tender, any of its constituents shall not separately bid for the same work in the e-NIT, or shall have no stake involving another bidder participating in the same work."

**In place of**

"In case of a Consortium or Joint Venture, the maximum number of constituents shall be restricted up to 3 (Three), all should be bonafide Indian entities as stated above and each of the constituents must have at least 20% of tender value as their individual average of annual turnovers from business in any three financial years within the zone of last five financial years and also fulfilling other PQ criteria. Individual constituents of a Consortium or JV cannot form another Consortium or JV to bid in the same work of the e-NIT. Where ever a JV/Consortium has submitted a tender, any of its constituents shall not separately bid for the same work in the e-NIT, or shall have no stake involving another bidder participating in the same work."

**2(a) In "TERMS OF REFERENCE" Clause 3.0 DREDGING CONTRACT PERIOD sub-para (i)**

**will be read as**

"(i) The Capping of Dredging quantity in Capital Dredging (Phase-I) & Capital Dredging (Phase-II) as stated in Table 1&2 of Terms of Reference, Sl.No 2 & 3 of A.I. Timelines and Physical Milestone & Sl.No.1 in the BOQ is relaxed. Capital Dredging (separately for both Phase I & II), maximum 10% variation on plus side in excess of the quantity mentioned in the BOQ, TOR & Timelines and Physical Milestone will be considered for measurement and payment in case the BOQ/TOR/ Timelines and Physical Milestone quantity is exhausted during attaining the guaranteed depth (2.5m below Chart Datum). For Capping on Maintenance Dredging, the quantities would be as per the values stated in Table 3,4,5&6 of Terms of Reference."

**in place of**

"(i) Capping of dredging quantities, both during capital and maintenance, would be as per the values stated in Table-1,2,3,4, 5 & 6."



2(b) In "TERMS OF REFERENCE" Clause 2.7 DELIVERY sub-para (d)

will be read as

"(d) All defects as and when arise are to be quickly attended to by the contractor, to ensure that any of the dredger(s) do not remain idle for more than 48 hours during the Phase-I of Capital Dredging, if replacement of Dredger is required than it should be replaced within **48 hours**. For Phase-II of Capital Dredging and Entire Maintenance Dredging period time allowed for replacement of faulty dredger will be **21 days**. In case any dredger remains idle due to some defects, immediate replacement is required in order to carryout Dredging uninterruptedly within the time frame."

in place of

"(d) All defects as and when arise are to be quickly attended to by the contractor, to ensure that any of the dredger(s) do not remain idle for more than **48 hours** during the working season. In case any dredger remains idle due to some defects, immediate replacement is required in order to carryout Dredging uninterruptedly within the time frame."

3. In "SPECIAL TERMS & CONDITIONS OF CONTRACT(SCC)" Clause 6

will be read as

"Labour Welfare Cess @ 1% of the cost of construction works shall be deducted from the Gross value of all works bills. Also it is instructed to compulsorily register his/her establishment under the Act, under the competent registering authority, i.e. Assistant Labour Commissioner / Dy. Labour Commissioner of the region for disbursing PF and ESI benefits of workers. The bidder should be mandatorily be registered online with Employees Provident Fund Organisation (EPFO) in the on-line system and posses EPF code and all current documents. Penalties and complaints due to non compliance of on-line EPF registration and default is the full responsibility of the bidder even if the TIA is by default the Principal employer. **Those organization which have medical & insurance coverage for all the employees need not produce the certificate for ESI registration, however, Notarized letter is to be submitted in this regard"**

In place of

"Labour Welfare Cess @ 1% of the cost of construction works shall be deducted from the Gross value of all works bills. Also it is instructed to compulsorily register his/her establishment under the Act, under the competent registering authority, i.e. Assistant Labour Commissioner / Dy. Labour Commissioner of the region for disbursing PF and ESI benefits of workers. The bidder should be mandatorily be registered online with Employees Provident Fund Organisation (EPFO) in the on-line system and posses EPF code and all current documents. Penalties and complaints due to non compliance of on-line EPF registration and default is the full responsibility of the bidder even if the TIA is by default the Principal employer"

4. While calculating, the rate as well as the total cost of dredging, GST has been considered as 5%. It is clarified that the rate would actually be 18%. Accordingly, the bidders are requested to consider and absorb this modification while quoting the rate.

All other terms and conditions will remain unchanged.
