Sealed Quotation in prescribed proforma are hereby invited by the Sub-Divisional Officer, Burdwan Irrigation Sub-Division No. III, Kanainatsal, Purba Bardhaman on behalf of the Governor of West Bengal for the “LIST OF WORKS” given in the next page from Bonafied Agencies / Organization, Contractors & General order suppliers having credential (from the Govt. Of West Bengal/ Central Govt / PSU /Other State Govt. Departments / Engineering Wings of GoI / Ircon / RVNL / NHPC, Autonomous body & other similar organizations) of execution of similar nature of work of value **Rs. 90,000/- (Rupees Ninety Thousand)** only during the current year and the last 5 years from the date of publishing of N.I.Q for a single work.

The intending bidders having valid licenses, PTPC& ITR, PAN, GST registration etc. should possess adequate experiences in the field of detail topographical survey for enabling the requirement of Engineering Department and other related Departments who deal with details information of the areas in respect of political, geographical, topographical, demarcation of boundary, water bodies, roads, railways buildings, hutments, rivers, canals, drainage channels, bridge, culverts and all other requisite information to have detail idea of the areas. Any additional input, if felt necessary by the department, is to be surveyed, incorporated and shown in the survey map to be handed over by the agency to the department. No additional expenditure in this connection will be borne by the department.

Prior to furnishing the Survey details i.e. cross sectional & long sectional drawing (Both in Excel & Auto Cad) along with Level Book in Excel (all are in Hard & Soft copy), the lowest bidder should get well acquainted with his assignment in details discussions with the Executive Engineer, Burdwan Irrigation Division or his authorized representative to avoid submission of any incomplete survey details, which is liable to be rejected. The Engineer-in-charge reserves the right in this regard to reject any/all incomplete (in terms of requirement of the department) survey drawing without assigning any reason thereof. The lowest bidder is liable to rectify any error/omission detected by the department at his own cost. No claim what so ever in this regard from the bidders will be entertained. The documents (Two sets) to be supplied both in hard and soft copies. The decision of the Engineer-in-charge is final and binding.

Scope of Work:-

- 1) Cross sectional & long sectional sheet @ 100mtr interval or less respectively, considering @ 3m to 5m interval level for Damodar Branch Canal (DBC) and the Distributaries Offtaking from Damodar Branch Canal and @ 1m to 3m interval for other Minor and Sub-Minor Canals (during taking cross section) for the Canals.
- 2) Two sets of cross sectional & long sectional drawings (Both in Excel & Auto Cad) along with Level Book in Excel (all are in Hard & Soft copy).
- 3) Any part of survey work, if not reflected inadvertently, is to be surveyed by the bidder at his own cost.
- 4) Detailed plan of Canal system showing structures (including outlets), Electric pole, Big trees (Dia.above 900mm), side drain/Borrow pits, houses or any other obstruction, inspection path.

The quotation should meet the following terms & condition which are given below:-

TERMS & CONDITIONS :-

- 1) The Executive Engineer, Burdwan Irrigation Division shall be the Engineer-In-Charge in respect of the above quotation & all correspondence should be made with the Engineer-In-Charge regarding the above survey work.
- 2) Additional project Director-III, DPMU-I, WBMIFMP, I&WD, Kanainatsal, Purba Bardhaman / Executive Engineer, Burdwan Irrigation Division, Kanainatsal, Purba Bardhaman, reserves the right to accept or reject the lowest or any other quotation without assigning any reason thereof.
- 3) The total survey work including submission of requisite Drawings in duplicate both in hard and soft copies separately which is mentioned in the scope of the work of the N.I.Q. is to be executed within **21 (Twenty one)** days from the date of issue of the work order. Finalization of drawing as stated above will rest upon the discretion of the Engineer-in-charge, no claim what so ever in this regard will be entertained.
- 4) The successful quotationer will have to execute formal agreement in W.B. Form 2911 as the case may be with Earnest Money @ 2 % of total value of quotation as per rules in the shape of Bank Draft in favour of the “**Executive Engineer, Burdwan Irrigation Division**” within 7 (Seven) days from the date of issue of the work order failing which the work order may be treated as cancelled.
- 5) Self attested photo copy of latest Income Tax, valid PAN / GST / Trade License and P.Tax Challan issued by the appropriate authority are to be enclosed along with the quotation, failing which the quotation will liable to be rejected.
- 6) The work order will be issued after acceptance of the rates of the quotation.
- 7) In case of office remains close or declared holiday or cannot function due to any reason the date stated above should be treated as the next working day.
