- 2. The car will be hired on daily rated monthly basis whose payment will be made by 'e-pradan system' in favour of the owner on the basis of bill submitted at the end of every month duly checked and passed by the Executive Engineer, Jhargram Flood Management & Planning Division.
- 3. The vehicle must have contract carriage permit for whole West Bengal
