

8	Annexure-8 / Para- 27, Page 13	Warranty Certificate The Warranty Certificate from the rubber fabric manufacturer shall be submitted in favour of the Authority and contain all the following provisions: a) The manufacturer warrants the fabric portion of each rubber dam installed from defects in material and workmanship excluding normal wear and deterioration for a period of 20 (twenty) years from the date of acceptance of the completed installation, assuming reasonable periodic maintenance by the Authority in accordance with the recommendation of the manufacturer.	Warranty Certificate The Warranty Certificate from the rubber fabric manufacturer shall be submitted in favour of the Authority . In addition to this, manufacturer must submit declaration regarding expected design life of membrane to facilitate planning of future renovation/re-installation by the Authority.
