Gantry girder and modification of electro-mechanical trolley movement by adopting E.O.T system of emergency gate trolley including all necessary civil & electro-mechanical work complete in all respect at Mukutmanipur Spillway gate, P.O- Gorabari, Block-Khatra, Dist- Bankura "**

Submission of EOI:-

The intending agencies should submit their most competitive budgetary quoted as per current market price in the prescribed BOQ Format annexed to the notice in a sealed envelope supers cribbing on the top " **Re-alignment and adjustment throughout the length of rail along with gantry girder of size-600x200, length-12mtr.(Approx.) each, total 12x2=24nos. Gantry girder and modification of electro-mechanical trolley movement by adopting E.O.T system of emergency gate trolley including all necessary civil & electro-mechanical work complete in all respect at Mukutmanipur Spillway gate, P.O- Gorabari, Block-Khatra, Dist- Bankura** The intending agencies / manufacturer should submit their EOI as per format enclosed here with . Their proposed BOQ Rate and amounts should be filled up properly.

The quoted rate should be inclusive of all taxes and duties.

Agencies (Or their authorised representatives) Participating in the EOI may remain present during opening of the sealed covers quoting EOI .

Selection of appropriate EOI entirely rests upon the competent authority. The authority reserves the right to accept or reject any or all EOI's without assigning any reason thereof.

As the notice inviting EOI is made for estimation purpose, no work order will be issued and no expenditure and / or payment whatsoever would be borne by I. & W. Department for submission of EOI .

Eligibility criteria:

1. Applicant or at least one member of the Consortium (in case applicant is a consortium) should have experience of successfully setting up at least two same nature work.
2. Applicant shall have a sound knowledge of above mention work and executing work related to total station in any State Government / Central Government.

Site visit and Presentation: Applicants shall be required to make a site visit before submission of EOI and also submit necessary drawing during submission of EOI.

Prebid meeting: Agency shall be require to present in prebid meeting which will be held on 15.07.2019 for discussion and they should submit their technical proposal in order to finalisation of B.O.Q.

Pre-qualification / Credential :-

The intending agencies will have to submit self-attested copies of completion certificates in support of his experience of executing work related to total station in any State Government / Central Government during last 2 (Two) years PAN, Trade license , GSTIN, P.Tax along with the EOI (Only completed works are to be considered)




