4. **a.** Intending Tenderers should apply for Tender papers in their respective Letter Heads enclosing self attested copies of the following documents, originals of which and other documents like Register Partnership (for Partnership farms) etc. are to be produced on demand, as well as during interview (if any).
 - i) Professional Tax Payment Certificate (PTPC), GST Enrollment No. and IT PAN Valid upto the date of opening of the Tenders, Application for such clearance addressed to the Competent Authority, subject to production of authenticated receipt, may also be considered.
 - ii) Completion Certificate for the Single similar work at least 30% of the value of the work for which Tender Paper is desired, executed within last 5 (Five) years (to be determined from the actual year of completion, considering current financial year as Year-1).
 - iii) A Statement showing number and value of works presently under execution by the Tenderer under the Irrigation & Waterways Department & other Govt. Departments/Organizations as stated in paragraph 4(b) here under.
 - iv) Declaration by the Applicant to the effect that there is no other applications for Tender Paper for work in this NIT in which he/ She/ they has/ have common interests. Failure to produce any of the above documents may be considered good and sufficient reason for non issuance of tender paper.**b.** Completion Certificate issued by Competent Authority will normally be considered as credential. Apart from credentials of works executed under Irrigation & Waterways Department, credentials of work executed under Public Works & Public Works (Roads) Departments, Public Health Engineering Department, Sundarban Affairs Department & other State Government Departments, Zilla Parishads, WBHIDCO, WBSEDCL, KMDA, KMW & SA, KMC, HRBC, Engineering Departments of Central Government and Organizations like Railways, KOPT, and Mackintosh Burn Ltd. Westinghouse Saxby Farmer Ltd. & Britania Engineering Ltd. May also be Considered. Completion certificates are to be countersigned by the Executive/ Divisional Engineers of the respective State/Central Government Departments, or Officer of the equivalent rank, if those are issued by some other authority.
