The intending agencies are requested to see the work site for being well acquainted with the actual site condition before submission of their quotation.

Rate should be quoted both in figures as well as in words in the specified annexure supplied by this office (free of Cost) and the rate must be inclusive of all taxes, GST as applicable, charges and all other incidental charges and cost of all allied works/supply. Conditional rate will not be accepted.
