- The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him. 27
- 28 Any letter or other instrument submitted separately in modification of the sealed tender will not be entertained.
- Conditional Tender, which does not fulfil any of the above conditions, and is incomplete if any respect, is liable to summary rejection. 29
- 30 Authority to issue tender forms for works other than once applied for is reserved by the Executive Engineer, East Midnapore Division.
 - The successful Tenderer will have to execute the duplicate/triplicate/quadruplicate copies of his tender which will have to be obtained free of cost from the office of the Executive Engineer, East Midnapore Division within? (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
