- **C)** Intending agency/Contractor will have to produce set (non refundable) of photocopy with self attestation by full signature of pan card, Professional Tax Challan, SARAL (ITR) which will be valid up to the date of opening of the tender at the time of application, otherwise no quotation paper will be issued.
- **D)** By law, pan card, Professional Tax clearance certificate, one set (non refundable) of photocopy with self attestation by full signature for Unemployed Engineers Co-operative, Labour Co-operative, valid up to the date of tender at the time of application, otherwise no tender paper will be issued.
