1. The Government of India **has applied** for financing from the World Bank toward the cost of the **West Bengal Major Irrigation and Flood Management Project (WBMIFMP)** Project and intends to apply part of the proceeds toward eligible payments under the contract¹ for construction of works as detailed below.
2. Bidding will be conducted through national open competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “**Procurement Regulations for IPF Borrowers, July 2016 Revised August 2018 and November 2018**” (“Procurement Regulations”), and is open to all Bidders as defined in the Procurement Regulations.
3. The **SPMU - WBMIFMP (implementing agency)** now invites online Bids on “lots within Package basis” from eligible Bidders for the construction of works detailed

below in the table. Bidders may quote for each individual lot or also for more than one lot. Interested bidders may obtain further information at the address given below during office hours. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 3.14 and 3.15 of the “Procurement Regulations” setting forth the World Bank’s policy on conflict of interest.

4. The bidding document is available online on <https://wbtenders.gov.in> OR www.wbiwd.gov.in from 13/12/2019 (from 18:45 Hours IST) to 14/01/2020 (upto 12:00 Hours IST) free of cost. Bidders will be required to register on the website, which is free of cost. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
5. For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://wbtenders.gov.in>.

Any bidder not having the DSC may obtain the same from NIC on payment of requisite fees, before the bid submission deadline.

6. Bids must be submitted online on <https://wbtenders.gov.in> on or before 14/01/2020 up to 12:00 hours IST and the ‘Technical Part’ of the bids will be opened publicly online on the same day at 16:00 hours IST. The “Financial Part” shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
7. All Bids must be accompanied by a Bid Security of the amount specified for the work in the table below, in the approved form in favour of **Chief Engineer and Project Director, SPMU – WBMIFMP** and shall have to be valid for 45 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 8.
8. The bidders are required to submit (a) original bid security in approved form and (b) original affidavit regarding correctness of information furnished with bid document with **Chief Engineer and Project Director, SPMU, WBMIFMP, Jalasampad Bhavan, Western Block, Bidhannagar, Salt Lake City, Ninth Floor, Kolkata - 700-091, West Bengal**, before the bid submission deadline, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be evaluated.
9. Other details can be seen in the bidding document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system


