NOTICE INVITING TENDER No. 07of 2019-20

- Separate sealed Tenders in printed form [W.B.F. No. 2911] are invited by the ExecutiveEngineer, Calcutta Drainage Outfall
 Division, on behalf of the Governor of West Bengal, for the works as per list and time schedule attached herewith. From
 eligible bonafide, reliable and resourceful outside Contractors having sufficient experience in execution of similar type of
 works as per categorization, detailed hereinunder.
- a. Separate Tender should be submitted for each work, as per altached List, in sealed cover super scribing the name of the work on the envelope and addressed to the proper authority.
 - b. Submission of Tender by Post is not allowed.
- The Tender documents and other relevant particulars (if any) may be seen by the intending Tenderers or by their duly authorized representatives during office hours in the Office of the Executive Engineer. Calcutts Drainage Outfall Division.
- 4. a. Intending Tenderers should apply for Tender Papers addressing Executive Engineer, Calcutta Drainage Outfall Division, in their respective Letter Heads enclosing self-attested copies of the following documents, originals of which and other documents like Registered Partnership (for Partnership Firms) etc. are to be produced on demand, as well as during interview (if any).
 - Trade License valid at least up to the date of opening of the Tenders. Application for such clearance addressed to the competent authority, subject to production of authenticated receipt, may also be considered.
 - Valid GSTIN under GST Act & Rules, Valid PAN card in the name of bidder/organization, Latest IT Return. Latest Professional Tax Payment Certificate (PTPC) or, PT deposit challen for current financial year,
 - III. Completion Certificate / Payment Certificate(s) for one single similar nature of work worth at least 30% of the value of the work for which Tender Paper is desired, executed during the current year and within last 5 (Five) financial years will only be accepted as valid credential.
 - iv. Completion Certificate(s) submitted by the tenderer should indicate the monetary value of the work executed within the last 5(five) years. Monetary value of the work will be further multiplied by the following factors to take care of the inflationary effects to arrive at the net notional amount.

- v. A Statement showing number and value of works presently under execution by the Tenderers under the Irrigation & Waterways Department and other Government Departments / Organizations as stated in paragraph 4(b) hereunder.
- VI. Declaration by the Applicant to the effect that there is no other applications for Tender Paper for the, work in this NIT in which he / she / they has / have common interests. Failure to produce any of the above documents may be considered good and sufficient reason for non-issuance of tender paper.

vii Any contractor/bidder may bid for any number of Serials of work in a particular e-NIT, if more than one work have been published in that NIT, subject to fulfillment of the following condition:

There should be full compatibility (matching between the technical PQ credential submitted by the bidder in the form of Credential Certificate (CC) along with other relevant documents) relating to any work successfully completed by the bidder and technical PQ criteria specified in the NIT for any particular serial of works for which the bidder intends to bid. In other words, technical PQ credential certificate along with relevant documents submitted for any work should at the minimum; satisfy the technical PQ eligibility criteria specified for that work. Normally there should be separate CC along with relevant documents for each of the serial of works, the bidder intends to bid and the serial number relevant to the CC should be

clearly written on the body of the CC and also on the other documents. However, the bidder will also reserve the right to submit one CC along with relevant documents for bidding in more than one serial of work, provided cumulative technical PQ credential of all such serials should be fulfilled by one single CC. In such case also, serial numbers of the relevant works for which the CC is submitted should be clearly written on the body of the CC by the bidder. Omission of serial numbers on the body of the CC and also on the other documents in case of bidding for more than one serial will lead to rejection of all the bids.

- Completion Certificates issued by Competent Authority will normally be considered as credential. Apart from credentials of works executed under Imigation & Waterways Department, credentials of works executed under Public Works & Public Works (Roads) Departments, Public Health Engineering Department, Sundarban Affairs Department & other State Government Departments. ZilaParishads. WBHIDCO, WBSEDCL, KMDA, KMW&SA, KMC, HRBC, Engineering Departments of Central Government and Organizations like Railways. KoPT, and Mackintosh Burn Ltd. Westinghouse Sexby Farmer Ltd.&Britania Engineering Ltd. may also be considered. Completion certificates are to be countersigned by the Executive / Divisional Engineers of the respective State / Central Government Departments, or Officer of the equivalent rank, if those are issued by some other authority. Over and above the completion certificates, certificate from the competent authority regarding payment received so far for the work (even if the full payment might not have been received), supported by Bank Statement showing that the corresponding amount of payment has actually been deposited in the Bank, will have to be produced in the cases of works executed under Departments / Organizations other than Irrigation & Waterways Department, failing which credentials may not be considered.
- c. Any suppression / misrepresentation of fact will automatically debar the applicant from participating in any Tender under the Division / Circle for at least 3 (Three) years from the date of detection, in addition to such other penal action as the Government may deem proper.
- 5. Intending Tenderers not satisfied with the decision of the Tender Paper Issuing Authority may prefer an appeal to the next superior Officer. Concerned Chief Engineer will be the Appellate Authority for High Value Tenders. Necessary communication regarding his appeal to the Appellate Authority must be brought to the notice of such authority within two working days after the date of issue of tender paper, and copy of such communication should also be submitted to the Tender Paper Issuing Authority within the same period, failing which no such appeal will be entertained.
- a. Tender paper will be supplied to the applicant free of cost from the office of the Executive Engineer, Calcutts Drainage
 Outfall Division, within the specified date and time as per attached list by the intending Tenderers or by their duly
 authorized representatives
 - No tender paper will be supplied by Post.
 - c. No tender paper will be issued on the date of opening of tenders after expiry of date and time mentioned in the Notice.
- 7. Before submitting any Tender, the intending Tenderers should make themselves acquainted thoroughly with the local conditions prevailing, by actual inspection of the site and take into considerations all factors and difficulties likely to be involved in the execution of work in all respects including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local labourers and market rate prevailing in the locality etc. as no claim whatsoever will be entertained on these accounts afterwards. In this connection the intending Tenderers may contact the office of the undersigned.
- 8. Earnest Money, as noted in the list of works, in the form other than those mentioned below, will not be accepted
 - a. Bank Draft, Banker's Cheque. Deposit Call Receipt (DCR) of schedules Banks guaranteed by the Reserve bank of India and having branch in West Bengal may be accepted as Earnest Money and/or Security Deposit in favour of Executive Engineer, Calcutta Drainage Outfall Division.
 - No adjustment of any sort of above mentioned Earnest Money previously deposited for other works will be considered.
 Tender without the specified earnest money will be treated as informal.
- 9. Earnest Money for works in open tender, as noted in the list of work, will have to be deposited by the Tenderers.
 - a The Tenderers should quote the rate both in figures and in words on the basis of percentage above / below or At Par the Schedule of Rates attached with the Tender Form and also in the space provided in the Tender Form and Schedule of Rates;
 - Any tender containing over writing is liable to be rejected;
 - All corrections are to be attested under the dated signature of the Tenderers.
- When a Tenderers signs his Tender in an Indian Language, the total amount tendered should also be written in the same language. In the case of illiterate Tenderers, the rates tendered should be attested by an witness.
- 11. The Tenderers who will sign on behalf of a Company or Firm, must produce the registered documents (within 3 days from the date of opening the tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- Any letter or other instrument submitted separately in modification of the scaled tender may not be entertained.

- 13. The Tenderers should submit a statement of the time of submission of his tender showing the Technical Staff to be maintained for the work, with their technical qualifications, failing which the tender may be liable to rejection.
- Conditional tender, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to summary rejection.
- 15. GST, Royalty, Building & other Construction Workers' Cess and all other statutory Levy / Cess etc. will have to be borne by the Contractor (he will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work).
- 16. The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without assigning any reason whatspever to the Intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers.
- 17 The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him.
- 18. The tenders will be opened, as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives, who may be present at the time of opening and who may also put their signatures in the Tender Opening Register.
- 19. The successful Tenderer will have to execute the duplicate / triplicate / quadruplicate copies of his tender which will have to be obtained by the office of the Executive Engineer, Calcutta Drainage Outfall Divisionfree of cost within 7 (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
- 20. If any Tenderer withdraws his tender before its acceptance or refuses / fails to convert it into a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal / refusal / failure, he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- The successful Tenderer will have to abide by the provisions of the West Bengal Contract Labour (Regulation and Abolition)
 Rules, 1972 and such other Acta as may be applicable, as will be in force from time to time.
- 22. Materials such as Cement, M.S. Rod, R.C.C. Hume Pipes, M.S. Sheet Piles, etc. if available in stock, will be issued by the Department to the Contractor for the work as per Issue Rate fixed by the Engineer-in-charge. Site of issue of materials as mentioned in the list of materials to be supplied Departmentally to the Contractor is furnished with the tender documents for the work. Any other materials not listed therein, if supplied by the Department, the Issue Rate for such material will be fixed by the Engineer-in-charge. If such materials are unavailable in stock, local purchase may be considered on permission from the Engineer-in-charge.
- 23. Hire charges for Loois & Plants, Machinery, if issued departmentally, will be recovered from the Contractor at such rates as will be fixed by the Engineer-in-charge. The period of hire charges of all Tools & Plants Machinery issued from the Government godown will be counted from the date of their issuance from the Goldown and up to the date of return into the same godown and the hire charges will be recovered from the Contractor accordingly. All Tools & Plants, Machinery issued to the Contractor must be returned in good condition. In the case of any damage, the cost of repair to such damage or replacement will be recovered from Contractor.
- In the following cases a tender may be declared informal and unacceptable.
 - Correction, atterations, additions, etc. I not attested by the Tenderer;
- i. Earnest Money other than as mentioned in St. No. 8 above.
- Earnest Money as mentioned in St. No. 8 above which are short deposited and/or not deposited in favour of the Executive Engineer, Calcutta Drainage Outfall Division;
 - c. If the Tender Form is not properly filled in respect of the general description of the work, Estimated Cost, Rate of deduction of Security Deposit, etc. in page-2 and other pages as are required to be filled in.
 - d. If the specified pages of the tender document are not signed by the Tenderer;
 - e. If the tender is not submitted in a Cover property sealed and the name of the work is not indicated on the cover.
- 25. For the return of the Earnest Money of the unsuccessful Tenderer(s), he/they is/are to apply for the same to the Executive Engineer, Calcutta Drainage Outfall Division, giving the reference to the work, N.I.T. No., date of tender, amount and mode of Earnest Money deposited all in a complete form. The Earnest Money of all Tenderers other than the lowest Tenderer in each case, may be refunded, after acceptance of the rate in the comparative statement, as early as possible.
- To verify the competency, capacity and financial stability of the Intending Tenderer(s) the Tender Paper Issuing Authority
 may demand production of any necessary document(s) as it may deem necessary.

- The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due to delay in payment will be entertained.
- Clause 25 substituted and modified in accordance with the enclosed Government order.
- 29. Earnest Money deposited by the successful Tenderer(s) during the tender shall be converted as a part of security money and additional security shall be deducted from the progressive bills at 8% or such amount from each such bill, so that the total deduction together with the 2% EMD constitutes 10% of the tendered value of work as actually done.
