NOTICE INVITING EXPRESSION OF INTEREST (EOI-03 OF 2019-20/EE,KMD, KHATRA)
(For Budgetary Purpose)

Expression of interest for obtaining budgetary quotes at competitive current market prices is being invited by Executive Engineer, Kangsabati Mechanical Division, Khatra , Bankura from reliable reputed resourceful agencies/manufacturer in connection with determination of estimated cost for "Renovation of Rail along with Girder, fixtures ,gate, electro-mechanical hoisting system, trolley movement, Construction of shed and painting along with all necessary civil work complete in all respect at Mukutmanipur , P.O- Khatra, Dist- Bankura ".

Issue of EOI documents:-

The EOI documents can be downloaded from the Departmental Web site www.wbiwd.gov.in as well as can be seen from the Office of the Executive Engineer, Kangsabati Mechanical Division, Khatra , Bankura during Office hours on all working days up to 25.02.2020 up to 3.00 P.M.

Submission of EOI:-

The intending agencies should submit their most competitive budgetary quote based on their proposal as per current market price in the prescribed BOQ Format(Annexed to this notice) in a sealed envelope supers cribbing on the top "Renovation of Rail along with Girder, fixtures ,gate, electro-mechanical hoisting system, trolley movement, Construction of shed and painting along with all necessary civil work complete in all respect at Mukutmanipur , P.O- Khatra, Dist- Bankura ".The intending agencies / manufacturer should submit their EOI as per Items to be framed by themselves based on their technical proposal.

The quoted rate should be exclusive of all taxes and duties.

Agencies (Or their authorised representatives) Participating in the EOI may remain present during opening of the sealed covers quoting EOI.

Selection of appropriate EOI entirely rests upon the competent authority. The authority reserves the right to accept or reject any or all EOI's without assigning any reason thereof.

As the notice inviting EOI is made for estimation purpose, no work order will be issued and no expenditure and / or payment whatsoever would be borne by I. & W. Department for submission of EOI.

Eligibility criteria:

1. Applicant or at least one member of the Consortium (in case applicant is a consortium) should have experience of successfully setting up at least one same nature work.
2. Applicant shall have a sound knowledge of above mentioned work and have executed similar work along with Gate and hoisting system of Dams.

Site visit and Presentation: Applicants shall be required to make a site visit and make a presentation before the submission of EOI and also submit necessary drawing during submission of EOI.

Slope of work:-

1. Re-alignment of Gantry Girder (re-setting of RSJ, if necessary) along with all necessary civil work.
2. Replacement of Base plates along with Foundation bolt.
3. Examining condition of the Gantry Girder in respect of its strength and replacement of weak Girder, if necessary.
4. Dismantling of existing rail, supply and installation of new rail of designed section.
5. Examining the condition of gate. Replacement if necessary.
6. Renovation of hoisting system of Emergency gate.
7. S.I.T.C of Electrical system for hoisting and trolley movement.
8. Construction of shed for Gate repairing
9. Designing and drawing wherever applicable will have to be prepared and submitted by the agency to the undersigned to get it approved.
10. Painting.




