**"Engagement of hiring one 30 K.V.A. capacity soundless diesel operated Eco Green Generator Set, C.P.C.B. approved with supply of Diesel, Mobile, Operator & maintenance complete for the use of the Office of the Superintending Engineers, Office of the Executive Engineer, Bankura Irrigation Division, including its Sub-Divisions at Bankura and Office of the Executive Engineer, Kangsabati Design Division including fitting fixing and installation with necessary wiring charge if required".**

Quotation will be received by the Executive Engineer, Bankura Irrigation Division at his office up to 3.00 P.M. on 17.03.2020 and will be opened on same day at 3.30 P.M.

Quotation imposing condition by quotationers will summarily be rejected. The successful quotationers will have to execute formal agreement with undersigned in relevant documents within seven days from the date of issue of Work order. Any sorts advance payment will not be entertained. The operator of the said generator will be engaged by the agency. This office will not take any liability in any shape for the operator.

**Description/Specification of Work:**

The Generator Set 30 K.V.A. **capacity soundless diesel operated Eco Green Generator Set, C.P.C.B. approved** should kept ready from 10 A.M. to 5.30 P.M. during office hours except Sundays and holidays. The Generator set should be installed with necessary wiring including earthing if required to connect with existing building wiring Main switches with automatic changeover and no extra payment for this purpose will be met up from this end. In the case of any emergency during irrigation period, March Final, and visiting of V.I.P.s etc. the Generator set with operator should be kept ready for operation even beyond 5.30 P.M. if required. The undersigned will not take any sorts of responsibilities for extra payment for the purpose. The hire charge of 30 K.V.A. **capacity soundless diesel operated Eco Green Generator Set, C.P.C.B. approved** is fixed for every month which will be effective for one year or as decided by the authority. During this period no further claim will be entertained. The installation with required fittings, connection wiring, automatic changeover, remuneration of operator, and cost of consumption of Diesel & other lubricant should be included within monthly hire charges.
