Enterprises or Nationalised Institutions or Local Government Bodies(Municipalities, Zilla Parishad & Panchayat Samities within West Bengal, will also be considered as valid credential. Such CC are to be issued by an officer/authority not below the rank of Executive Engineer / Divisional Engineer / District Engineer/Project Manager of the State/Union Government Departments/ Organisations; authorised signatories of CC for Panchayat Samities and Municipalities shall be the BDO & Executive Officers or equivalent administrative officers respectively.

- 4 Each applicant for tender form is to be accompanied by self attested copies of the following:

- The "Additional Perfrmance Security" shall be obtained from the successful L1 bider if the accepted bid value is below 20% of the estimated amount put to tender. This Additional Performance Security shall be equal to 10% of the tender amount i.e the L1 bid price.

- 7 Tender forms will be issued only to applicant himself or his duly authorized agent on personal appearance.

- Conditional Tender, which does not fulfil any of the above conditions, and is incomplete if any respect, is liable to summary rejection. 29
- 30 Authority to issue tender forms for works other than once applied for is reserved by the Executive Engineer, East Midnapore Division.
- The successful Tenderer will have to execute the duplicate/triplicate/quadruplicate copies of his tender which will have to be obtained free of cost from the office of 31 the Executive Engineer, East Midnapore Division within7 (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
- If any Tenderer withdraws his tender before its acceptance or refuses/fails to convert it into a contract within a reasonable time, without giving any satisfactory 32 explanation for such withdrawal/refusal/failure, he shall be disqualified for submitting any Tender in this Division/Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
