4.(V)	Any contractor/bidder may apply for any number of Serials of work in a particular Offline NIT, if more than one work have been published in that Offline NIT, subject to fulfillment of all of the following condition: There should be full compatibility (matching between the credential submitted by the bidder in the form of Credential Certificate (C.C) along with other relevant documents relating to any work successfully completed by the bidder and technical criteria specified in the NIT for any particular serial of works for which the bidder intends to bid. In other words, technical credential certificate along with relevant documents submitted for any work should at the minimum; satisfy the technical eligibility criteria specified for that work. Normally there should be separate C.C along with relevant documents for each of the serial of works, the bidder intends to bid and the serial number relevant to the C.C should be clearly written on the body of the C.C and also on the other documents stated. However, the bidder will also reserve the right to submit one C.C along with relevant documents for apply in more than one serial of work, provided cumulative technical credential of all such serials should be fulfilled by one single C.C. In such case also, serial numbers of the relevant works for which the C.C is submitted should be clearly written on the body of the C.C by the bidder.
