This e-Procurement notice includes the terms and conditions applicable to submission of quotations; criteria for qualification, evaluation, and for award of contract; and relevant forms to be filled by the bidders. Implementing Agency has not issued a separate RFQ document for this purchase. The e-Procurement notice including the terms and conditions etc. can be downloaded free of cost by logging on to the website https://wbtenders.gov.in. The bidders would be required to register in the website which is free of cost.
- 3. For submission of Quotation, the Bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorized by Government of India for issuing DSC. - 1. Eligibility: A Bidder (a) shall not participate in more than one Quotation; (b) shall not have conflict of interest as defined in the Bank's Procurement Guidelines; and (c) should not have been (i) temporarily suspended or debarred by the World Bank Group in compliance with the Bank's Anti-Corruption Guidelines and its Sanctions Framework; or (ii) blacklisted or suspended by Government Department/Semi-Government/Public Sector Organization in India. - 2. 4. Quotation Prices:

- (a) The contract shall be for the whole of the services, as specified in the Price Quotation Form. Corrections, if any, can be carried out by editing the information before electronic submission.
- (b) The Bidder shall be responsible for meeting all tax liabilities other than Goods and Services Tax (GST) arising out of the Contract.
- (c) GST, which will be payable on the services at the time of invoicing, shall be shown separately.
- (d) The rates quoted by the Bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

- (e) The Prices shall be quoted in Indian Rupees only.
- (f) Each bidder shall submit only one bid.
- **5.** Qualification of the Bidder: Bidder should have performed services of similar nature and complexity of value of at least INR 20 lakh (Rupees twenty lakh) only in any one of last 3 years. Details of services performed during the last 3 years shall be submitted in the specified Proforma. [copy of Work orders, Schedule of works, Completion Certificate from the competent authority for all are to be attached]
- **6. Validity of Quotation:** Quotation shall remain valid for a period not less than 45days after the deadline date specified for submission.
- 7. **Signing of Quotations**: The **name and position** held by each person signing the quotation and related documents must be typed or printed below the signature.
- **8. Quotation Submission**: The Letter of Quotation shall be filled, **signed and scanned** copies shall be uploaded along with the Price Schedules that shall be furnished using the Forms available online without any alterations. All blank spaces shall be filled in with the information requested. Scanned copies of all other documents shall also be uploaded on this website.
- 9. Deadline for Submission of Quotations: Quotations must be uploaded online, not later than the deadline for submission of quotations by 15:00 hours on 10.09.2020 as per server time. Quotations once withdrawn cannot be resubmitted.
- 10. Online Opening and Evaluation of Quotations: The Quotations will be opened online on the specified date and time. This can also be viewed by the Bidder online, and electronic summary of quotation opening will be generated and uploaded online.
 - (a) The Employer shall examine the quotation to determine whether the quotation (a) has been properly signed (Clause 7); (b) meets the eligibility criteria& qualification criteria (Clause 1& 5); and (c) Price Schedules are in accordance with the requirements specified in the RFQ document.
 - (b) Only Quotations that are both substantially responsive to the RFQ document and meet all Qualification Criteria shall qualify for financial evaluation.
 - (c) The evaluation shall be based excluding GST and including any other taxes.
 - (d) Employer shall **notify in writing** those Bidders who have failed to meet the Qualification Criteria or whose Quotations were considered non-responsive to the requirements in the RFQ document, advising them that their Quotation failed to meet the requirements of the RFQ document.

- (a) Notwithstanding the above, the Employer reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- (b) Regarding required number of **substantially responsive bidder**, World Bank's "Guidelines -Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits and Grants by World Bank's Borrowers" Revised July 2014, may be followed.
- (c) The Bidder whose quotation is accepted will be notified of the award of Contract by the Employer **prior to expiration of the quotation validity period**.
- (d) 100 % payment may be made within 30(Thirty) days of receipt of all deliverables maintaining all specifications, terms & conditions, acceptance of the same, receipt of invoice subject to availability of fund. Payment of GST for the services at the time of invoicing, although already included in the total cost, will be at actual.
- 12. Performance Security: Within 15 days of receiving Letter of Acceptance, the successful Bidder shall deliver to The Executive Engineer, Burdwan Investigation & Planning Division, Irrigation & Waterways Directorate, Govt. of West Bengal (Employer) the performance security (either a Bank Guarantee or a Fixed Deposit/Term Deposit Receipt in favour of the Employer) for an amount equivalent of 5(five) % of the contract price. The Performance Security shall be valid beyond 45 days the contract completion period. Failure of the successful Bidder to furnish performance security and to sign the agreement within the period stipulated shall constitute sufficient grounds for annulment of award and debarring the bidder from participation in bidding for services/works by the Employer for a period of one year, in which case the Employer may make the award to the next lowest evaluated Bidder or seek quotations afresh.
- 13. Supply of all materials and equipment shall be the responsibility of the Bidder. Employer will not issue any material/equipment.

DESCRIPTION OF SERVICES

1. Background:

West Bengal specially Hooghly district crisscross with a number of rivers/khals etc. Many of these streams are used for irrigation purpose and others are mainly for drainage channels. These streams are often carry flood discharge during monsoon period. Hence an integrated data of embankment/bank of these rivers/khals are of huge importance.

2. Objective(s) of the Assignment

- 1. Detail topographic & hydrographic survey along rivers/khals at suitable intervals,
- 2. In-situ geo-technical investigation of soil samples along embankment / bank line of those rivers/khals at suitable intervals.
- **3.** Collection of soil samples along embankment / bank line of those rivers/khals at suitable intervals & carriage of same to River Research Institute, Haringhata, West Bengal for future laboratory tests.
- **4.** Construction of reference Bench Mark pillars along embankment / bank line of those rivers/khals at suitable intervals.

3. Scope of Services, Tasks (Components) and Expected Deliverables

A) Scope of Work:

The work shall cover all technical aspects of topographic & hydrographic survey, in situ geotechnical investigation of soil samples etc. at par with standards including the following:

The survey is to be carried out using survey instruments like Total Stations, DGPS-RTK, Ecosounder with Hypack Software and associated with GPS system to ensure accuracy and Georeference as per instruction of Engineer-in-Charge.

The field survey consists of:

- i)
- a) Detailed field survey of embankment/ and or bank of river/khal by taking cross sections @ not exceeding 250 m c/c (extending each cross section 10 m from country side toe line of both side embankments /country side end point of both side banks) w.r.t. G.T.S. Bench Mark value.
- b) Carrying out closed leveling from available nearest permanent GTS Bench Mark point up to present working locations for rivers/khals throughout as per direction of Engineer-in-Charge and providing all details with X,Y,Z co-ordinates using digital level instrument at appropriate places, raw data from digital level shall be submitted along with adjusted and unadjusted levels in tabular form & by using applicable Geo-Office software as per direction of Engineer-in-Charge.

Digital leveling instrument to be used for the work shall have the minimum accuracy of order 0.30 mm per km (double run) with least count not more than 0.01 mm.

ii) Conducting in-situ field density test by common balance, field moisture content test by rapid moisture meter, field permeability test by constant head method [at an average depth of 1.5 mtr from top of embankment/bank] @500 m c/c distance along both embankments and/ or

banks and submission of report after getting them certified by reputed Govt. organization/institute as per direction of Engineer-in-Charge.

- **iii)** Collection of undisturbed soil samples @1000 m c/c distance along both embankments and/ or banks from a suitable depth from top of embankment/bank & carriage of those samples with proper labeling of collection locations for assessment of different geotechnical and soil properties to River Research Institute, Haringhata, West Bengl, as per direction of Engineer-in-Charge.
- iv) Construction of Bench Mark pillars as per enclosed drawing and specification. This Bench mark pillars are to be constructed at suitable locations along rivers / khals as per direction of Engineer-in-Charge. A topographic map showing location of all such B.M. pillars with Georeference and corresponding G.T.S. B.M. values is to be submitted [Both soft & Hard copy] during submission of report. All those B.M. pillars are to be properly coloured and marked as per direction of Engineer-in-Charge.

4. Reporting Requirements and Time Schedule for Deliverables

Submission of report comprising detail drawings [both soft copy & hard copy] in the form of index map, topographic site plan showing all important features, cross sections & long sections of rivers/khals in suitable scale and relevant photographs etc. as per direction of E.I.C.

- a) Apart from the hard copy of report & drawings, soft copies of all survey data are to be submitted in Excel, Arc-GIS and AutoCAD format for records and further analysis.
- b) A .DWG & .KMZ/.KML file of the detailed topographic survey of the embankment/bank shall be made from the survey data such that the layer can be visualized in Google Earth/Arc GIS Earth.

Reports to be submitted time to time [after completion of one river/khal system as a whole] as per direction & satisfaction of Engineer-in-Charge.



2. Contract Price

The total Contract Price for the services (hereinafter referred to as the "total price") is INR (excluding/including(*Choose one option*)Goods and Services Tax).

2.1. Payments under the Contract

Payments to the second party for the services will be released by the first party in the following manner:

100% Payment to the second party for the works/services will be released by the first party after completion of all works/services as per schedule-specification by maintaining all terms & condition and receipt & acceptance of all deliverables as a whole as per direction & satisfaction of Engineer-in- charge.

- 2.2 Payments will be made on certification of the invoice by the Project Manager nominated by the first party with respect to quality/quantity of services executed in the format in **Annexure 2.**
- 2.3 **Project Manager**: The agency shall undertake the survey work of embankments of Hooghly district and corresponding mapping in consultation with the Executive Engineer-II, Lower Damodar Irrigation Division who will act as Engineer-in-charge & Project Manager on behalf of I &W Department.

3. Notice by Service Provider to Employer

The second party, on the services reaching each stage of execution, issue a notice to the first party or the Project Manager nominated by the first party (who is responsible for supervising the Service Provider, administering the contract, certifying the payments due to the Service Provider, issuing and valuing variations to the contract, awarding extensions of time etc.), to visit the site for certification of stage completion. Within 15 days of the receipt of such notice, the first party or the Project Manager nominated by it, will ensure issue of stage completion certificate after due verification.

4. Completion Time

The services should be completed in 3 (Three) months [90 days] from the date of this Agreement. In exceptional circumstances, the time period stated in this clause may be extended in writing by mutual consent of both the parties.

- 5. If any of the compensation events mentioned below would prevent the services being completed by the intended completion date, the first party will decide on the intended completion date being extended by a suitable period:
 - (a) The first party orders a delay for execution of the services on time.
 - (b) Ground conditions are substantially more adverse than could reasonably have been assumed before issue of letter of acceptance and from information provided to second party or from visual inspection of the site.
 - (c) Payments due to the second party are delayed without reason.
 - (d) Certification for stage completion of the services is delayed unreasonably.
- **6.** Any willful delay on the part of the second party in completing the services within the stipulated period will render him liable to pay liquidated damages. @ INR 0.05% of the contract value per day which will be deducted from payments due to him. The first party may cancel the contract and take recourse to such other action as deemed appropriate once the total amount of liquidated damages exceeds 5 % of the contract amount.

7. Duties and Responsibilities of the First Party

- **7.1** The first party shall be responsible for providing regular and frequent supervision and guidance to the second party for carrying out the services as per description of services. This will include written guidelines and regular site visit of the authorized personnel of the first party, for checking quality of services to ensure that it is as per the norms.
- **7.2** The Project Manager or such other person as may be authorized by the first party shall hold meeting once in a fortnight where the second party or his representative will submit the latest information including progress report and difficulties if any, in the execution of the services. The whole team may jointly inspect the site on a particular day to take stock of activities.
- 7.3 The Project Manager shall record his observations/instructions at the time of his site visit. The second party will carry out the instructions and promptly rectify any deviations pointed out by the Project Manager. If the deviations are not rectified, within the time specified in the Project Manager's notice, the first party as well as the Project Manager nominated by it, may instruct stoppage or suspension of the services. It shall there upon be open to the first party or the Project Manager to have the deviations rectified at the cost of the second party.

8. Duties and Responsibilities of the Second Party

8.1 The second party shall:

- (a) take up the services and arrange for its completion within the time period stipulated in Clause 2;
- (b) employ suitable manpower and equipment to carry out the services;
- (c) regularly supervise and monitor the progress of services;

- (d) abide by the technical suggestions/direction of supervisory personnel designated by the Employer;
- (e) be responsible for bringing any discrepancy to the notice of the representative of the first party and seek necessary clarification:
- (f) ensure that the service is carried out in accordance with specifications, drawings and within the total of the contract amount without any cost escalation;
- (g) keep the first party informed about the progress of services;
- (h) maintain necessary insurance against loss of equipment and property etc. or workman disability compensation claims of the personnel deployed on the services as well as third party claims.
- (i) pay all duties, taxes and other levies payable by service providers' agencies as per law under the contract (First party will effect deduction (TDS) from running bills in respect of such taxes as may be imposed under the law).

9. Variations / Extra Items

The services shall be carried out by the second party in accordance with the approved description of services. However, if, on account of any other factors, variations are considered necessary, the following procedure shall be followed:

- (a) The second party shall provide the Project Manager with a quotation for carrying out the Variation when requested to do so by the Project Manager. The Project Manager shall assess the quotation, which shall be given within seven days of the request before the Variation is ordered.
- (b) If the quotation given by the second party is unreasonable, the Project Manager may order the Variation and make a change to the Contract Price which shall be based on Project Manager's own forecast of the effects of the Variation on the Service Provider's costs.
- (c) The second party shall not be entitled to additional payment for costs which could have been avoided by giving early warning.

10. Securities

The Performance Security (either a Bank Guarantee in the format attached or Fixed Deposit/ Term Deposit Receipt from a Nationalized or Scheduled Bank in India) shall be provided to the Employer no later than the date specified in the Letter of Acceptance and shall be issued in an amount and form and by a bank or surety acceptable to the Employer. 11. Termination

11.1 By the Employer

The Employer may terminate this Contract, by not less than 15 days' written notice of termination to the Service Provider, to be given after the occurrence of any of the events specified below:

- (a) if the Employer fails to pay any monies due to the Service Provider pursuant to this Contract and not subject to dispute pursuant to Clause 10 within 45 days after receiving written notice from the Service Provider that such payment is overdue; or
- (b) if, as the result of Force Majeure, the Service Provider is unable to perform a material portion of the services for a period of not less than 30 days.

11.3 Suspension of Loan or Credit

12 Payment upon Termination

- (c) The Adjudicator shall be paid by the hour at the rate specified above together with reimbursable expenses for vehicle hire, food and lodging, if required, as agreed in connection with the adjudication procedure, and the cost shall be divided equally between the Employer and the Bidder, whatever decision is reached by the Adjudicator. Either party may refer a decision of the Adjudicator to an Arbitrator within 28 days of the Adjudicator's written decision. If neither party refers the dispute to arbitration within the above 28 days, the Adjudicator's decision will be final and binding.




