
Additional Terms and Conditions for QUALIFYING CRITERIA are as follows :

 - a) Tender Specific Authorization certificate and pre-qualification certificate signed by the local authorized OEM representative to participate in this NIT (tender) and having an experience of similar nature of work.
 - b) Authorized Converter Certificate from the Original Retro Reflective Sheet manufacturer.
 - c) Pre-qualification Warranty as per IRC: 67-2012 for 11 years for reflectivity of Type XI sheeting and for 7 years for reflectivity of Type IV sheeting issued by the local authorized OEM representative to participate in this NIT (tender).
 - d) Valid certificate of Accreditation issued by the statutory authority / IRC for retro-reflective material received from the Original Retro Reflective Sheet manufacturer, duly self attested by the local authorized OEM representative supported with third party Test Report.
 - e) Intending Bidders should submit a Declaration on a Non-Judicial Stamp Paper that they had never been Black Listed or Debarred for participation in any tender by any Central/State Government/Public Sector Undertaking.
 - f) Undertaking on a non-judicial stamp paper regarding that this contract shall not be sublet either wholly or partly.Bidders should submit Warranty Certificate of minimum 1 year along with pre-Qualification warranty of the materials to be supplied, issued by sheeting local authorized OEM representative.
