- Intending tenderer not satisfied with the decision of the tender paper issuing authority may prefer an appeal to the next superior officer. - Tenders with over writing or illegible writing are liable to rejection. Any correction should invariably be signed by the tenderer 23
- When tenderer signs his tender in any Indian Language the total amount tendered for should also be written in the same language. In case of illiterate tendered the rates of tenderers are to be attested by a witness. In the event of a tender submitted by a partnership firm, it must be signed by each of the partner of the firm or a person holding power of attorney as stipulated in the Indian Partnership Act

- The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without 26 assigning any reason whatsoever to the intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers

- Any letter or other instrument submitted separately in modification of the sealed tender will not be entertained 28
- Conditional Tender, which does not fulfill any of the above conditions, and is incomplete if any respect, is liable to summary rejection. 29
- 30 Authority to issue tender forms for works other than once applied for is reserved by the Sub Divisional Officer, Panskura Irrigation Sub Division No-II.
- The successful Tenderer will have to execute the duplicate/triplicate/quadruplicate copies of his tender which will have to be obtained free of cost from the office. 31 of the Sub Divisional Officer, Panskura Irrigation Sub Division No-II within 7 (Seven) days from the date of receipt of the infimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled
