Jalpaiguri and at Baghajatin Colony in P.S. Pradhan Nagar, at Jyotinagar Colony in P.S. Siliguri and at Kholai Baktiar area in P.S. Matigara, Dist. Darjeeling. (Phase-III).

Due to some unavoidable reason following information of "Minimum eligibility criteria to match the Prequalification (PQ) works credential" as mentioned in col.8 under List of Works (Page-2) of the NIT has been changed as follows:-

#### A. Technical PQ Credential:

The bidder must have satisfactorily completed at least 1 (one) work of 'similar in nature' under Government Sector within last five FYs on the date of publication of this NIT of Gross monitory value of Rs 212.74 lakh. (Gross monitory value is calculated based on final billed value given in Credential Certificate (CC) multiplied by inflationary factor executed within preceding five FYs of similar nature not be less than 30% of the amount put to tender of the work for which the bidder chooses to participate in this NIT. The same shall be minimum 60 % (Rs. 425.49 lakh) for Consortium/JV)
- ii.
