Notice Inviting Tender No. 01/SDO/ KISD of 2021-2022

- 1) Sealed Tender in W. B. Form no. 2911 is invited from bonafide resourceful contractors having desired credential and financial capacity for execution of similar nature of work as per list enclosed.
- 2) Details of works, earnest money to be deposited, date and time of issue / receipts of Tender paper, time allowed for completion of the work etc. are shown in the list enclosed.
- 3) Details of works to be done together with plan, Specification and additional terms and conditions etc. may be seen in the office of the under signed in any working day between 11.00 hrs. to 15.00 hrs.
- 4) Tender forms and the connected relevant Tender Documents may be available in the office of the Sub-Divisional Officer, Kandi Irrigation Sub-Division on working days upto the date and at the cost as shown in the enclosed list.
- 5) Tender which always be in sealed covers with the name of work, N.I.T. No. written on the envelop will be received by the Sub-Divisional Officer, Kandi Irrigation Sub-Division at his office up to date & hours as shown as specified in the list of work enclosed.
- 6) Agencies, desires to participate in the Tender, are requested to apply for tender forms etc. in plain papers including tested Xerox copies of the following documents as directed.
 - i) Certificate indicating works done during last five years.
 - ii) Payment certificate of similar works for the last five years items of work in the enclosed list.
 - iii) S.T, I.T., Vat & Latest Professional Tax Payment Certificate (PTPC) or PT payment challan for current financial year & valid Trade License.
 - iv) PAN
 - v) Valid GST Identification number (GSTIN) document under the relevant GST Acts & Rules of State Govt.
- 7) No Tender paper will be supplied by post.
- 8) Issue of Tender form/ Acceptance of Tender will rest with authority undersigned who does not bind himself to issue Tender Form/Accepted the lowest of any Tender and reserves to himself the right to reject any or all of the application for tenders forms/Tender received without assigning any reason.
- 9) Earnest Money Deposit (EMD) must be submitted in the form of Bank Draft (BD) / Bankers Cheque (BC) / Deposit Call Receipt (DCR) of any scheduled bank of India in favour of Executive Engineer, Berhampore Irrigation Division, payable at Berhampore, Murshidabad. Payment in any other form e.g. NSC, KVP, etc. will not be accepted.
- 10) The "Additional Performance Security" shall be obtained from the successful L1 bidder, if the accepted bid value is below 20% of the estimated amount put to tender.

This Additional Performance Security shall be equal to 10% of the tendered amount i.e. L1 bid price.

The Additional performance security shall have to be submitted by the selected bidder after issuance of Letter of Acceptance / Letter of invitation (LOA/LOI) and before Award of Contract (AOC) in the form of "Bank Guarantee" of any Schedule Bank, payable at Kolkata or / in West Bengal, as per enclosed format (Annexure). If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of LOA/LOI, its Earnest Money Deposit (EMD) will be summarily forfeited.

The said Bank Guarantee (BG) shall have to be valid up till the end of the Contract -Agreement period including extended time period till 100% physical completion of work in all respects and shall be renewed accordingly if required. The said Bank Guarantee shall remain in custody of the DDO & Executive Engineer in -charge of the work, which shall be returned to the bidder /contractor immediately after successful physical completion of the work as per contract.

If the bidder fails to complete the work successfully, this Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving suitable notice to the contractor/bidder agency.

Necessary provision regarding deduction of security deposit from progressive bills of the contractor in respect of the tendered work shall be governed as per relevant clauses of the tender contract-Agreement which will in no way be affected / altered due to this Additional Performance Security. This clause i.e. clause 28 included as per Memorandum circulated by Irrigation & Waterways Department, Govt. of West Bengal, vide Memo No. 09-W/2017-18, dated:- 20th July, 2017


