DETAILS OF CORRIGENDUM :- The changes of "Item no. 9 of B.O.Q." & "Extension of Bid submission end date in

the N.I.T" are shown in the table given below :-

Maintenance Dredging is to be undertaken during the mandatory Contract Period of 4 years(1st February 2019 upto 7th January 2023) by Cutter Suction Dredger (CSD). Maintenance dredging is to be carried out in the channel 1,2,3 as well as Patch-1 in order to maintain the depth of 2.5m below CD throughout the year. The Dumping of dredged material from Channel-1 will be done in a southern deep water pocket by suitable pipeline, 75% of dredged material from Channel-2 is to be dumped in northern deep water pocket and the rest 25% & the total dreged material from Channel-3 is to be dumped on shore as shown in figure in Annexure-4 (in drawing folder). The dreged material from the shallow patch near Kachuberia is also to be dumped in northern deep water pocket nearby.

Maintenance Dredging is to be undertaken during the mandatory Contract Period (from date as per work order upto 20th January 2022) by Cutter Suction Dredger (CSD). Maintenance dredging is to be carried out in channel 1 & 3 in order to maintain the requisite depth from 20th December 2021 to 20th January 2022. The Dumping of dredged material would be done in the designated dumping ground and as per direction of engineer-in-charge.
