"Carrying out bank to bank Cross Section @ 30m. for a length of 1.00 km. of Main canal, @ 50m. for a length of 0.500 km. of River Karati & @ 50m. for a length of 0.500 km. of Branch canal and Long Section Survey work with DBL of Canal by boat using Echo Sounder and/or Total Station instrument alongwith topographical survey by making 30m. grid encircling 300m. radius as per direction of the Engineer-in-charge alongwith preparation & submission of necessary survey drawings including calculation of volume of earthwork & topographical map showing 10 m. stretch from bank of canal on either side with report in both soft & hard copies for Jorha Khal, Branch Khal & River Karati in connection with proposed additional Pump House near the existing Kurebhanga Pump House at Mouza Jogendranagar, Block Canning-II, P.S. Jibantala, Dist – South 24 Parganas."
