1	Lifting of concrete block (Size-1.5 m X 1.5 m X 0.90 m or heavier) using hydra or Pocklin machine and other arrangement with all accessories, chain pully, anchorage, hoocking etc. and resetting the same block excluding the cost of CC block, GST and other as per direction of Engineer in charge.
