NOTICE INVITING: R.F.P.

WBIW/SE/MBC/ RFP- 01 (e)/2021-22

Request for proposal (RFP) is herby invited on behalf of the Governor of West Bengal from competent, resourceful & experienced agencies for "Gardening, Operating & Maintenance of Mahannada Barrage Park at Fulbari in Dist. Jalpaiguri & Darjeeling" on short term lease basis.

The Barrage park had been developed on both side u/s guide banks of the river at Mahananda Barrage with promenade & river site view with plenty of sitting arrangement & fresh air & rich collection of outdoor play items. The pond is a rich habitat of migratory birds. The place is along NH - 31D & hardly 6 Km from Siliguri.

Terms of reference:-

- The bidder have to apply for Bid documents before Superintending Engineer, Mahananda Barrage Circle with PAN, GSTIN, Latest IT return & Trade license & previous experience certificate. (of engaging manpower) operating similar establishment. Failure to satisfy those will lead to denial of bid document.
- The operator should have valid PAN; GSTIN & Trade License & 2. IT return etc & previous experience to engage at least10 manpower in Govt. organization for similar purpose.

- 3. Operator will have to engage sufficient manpower (with uniform & Id-Card) to guard & issue tickets & guide the park visitors.
- 4. The operator will be have to clean the premises regularly & clear off dry leaves & grasses etc on both bank parks (on guide bundh).
- 5. The operator will have to water the plants & apply fertilizer etc & care for its proper growth & health. He will have to replace the dead plant with a fresh one.
- 6. The operator will have to take up minor maintenance like plastering & mending damage of the pedestal for seating, colouring of water front railing / sports articles, setting & readjustment of paver blocks & fitting / replacing bolts / roller etc of the sports articles & other installations at park.
- , 7. Normally highest bidder / offer will be accepted though the same may be rejected by the authority without assigning any reason whatsoever.
 - 8. The contract will be initially for one year which may be extended for one more year based on satisfactory performance.
 - 9. The park will remain open strictly from 9.00 Am to 6.00 pm on all days of the week.
 - 10. Major repair of installation / premises & sports will be taken up by project authority.
 - 11. Electric charge of the lights / sports will be borne by the project authority. However, the electricity within the counter & camp will be borne by the operator.

- 12. The operator will have no right on the land / premise.
- 13. Entry fee @Rs. 20.00 / Rs. 30.00 (on Saturday / Sunday + National holydays) per person may be collected from the visitors (above, 3 years age/ 2.5' height). A visitor can enter both side parks on guide banks on the same ticket. Visitor can stay inside parks for 3 Hrs.
- 14. The operator will be responsible for any damage / unlawful activity by the visitors & so, he will have to strictly regulate the movements of the visitors.
- 15. The operator has to restrict the number of visitors at a time (not more than 30) & to follow the existing Government rule of COVID-19 & the park will be closed as per Government rule for preventing any pandemic situation.
- 16. The project authority may restrict / stop the entry of visitors temporarily during flood/ emergency or for taking up maintenance works etc.
- 17. The operator will have liberty to raise temporary structure for counter / post for issuing tickets / washroom/ watching, if approved by the project authority.
- 18. The operator will have to put up sufficient number of notices / boards warning visitors from walking down to river/ touching plants/disturbing the migratory birds, fishing or playing loud music etc.
- 19. Picnic, playing music & lighting fire of any kind are strictly prohibited.
- 20. The authority reserve the right to review the rate entry fee & to add or delete any of the term of reference with notice to the operator.

- 21. Any law & order problems will be dealt by the operator directly with the local administration with intimation to the project authority.
- 22. Unsatisfactory performance will lead to cancellation of the agreement with one months notice (on either side).
- 23. The authority reserves the right to curtail / restrict / withdraw any privileged to the operator / visitor. No claim / Compensation will be entertained in the regard.
- 24. The highest offered bidders will have to enter into an agreement with the project authority / Executive Engineer, Mahananda Barrage Division after due acceptance of the bid by Irrigation & Waterways Department.
- 25. The Bidder will have to attach to Demand Draft of Rs-10,000.00 in favor of Executive Engineer/Mahananda Barrage Division, payable at Siliguri as security deposit along with the bid-offer.
- 26. The highest bidder will have to deposit 50% of the offer within 10 days of issuance of letter of acceptance & rest 50% by the end of 5th month. The payment instrument will be in favour of Executive Engineer, Mahananda Barrage Division at Siliguri.
