- A brief mention in line with GCC 15.3 mentioned under PCC should be made at the beginning of the Construction Methodology.
- Construction methodology may be submitted in detail incorporating following components:
 - Methodology for preparation of sub base and laying of filter prior to lining in canal
 - Sheet pile works
 - Construction of inspection path over canal embankments by moorum over jhama
 / brick metal subbase
 - Special type of repair activities for rehabilitation of structures like shotcrete etc.
 - All types of Electro-Mechanical works
- Baseline environmental parameters as per notes under Appendix II/12 needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
