THE VEHICLE SHOULD BE WITH LUXURY CAR REGISTRATION.

THE VEHICLE SHOULD BE DIESEL DRIVEN. 2

THE RATES SHOULD BE QUOTED SEPERATELY ON THE BASIS OF THE FOLLOWINGS: 3

A PER DAY EXCLUSIVE OF FOUL.

B OVERTIME RATE PER HOUR EXCLUSIVE COST OF FOUL FOR EXCEDING 10 (TEN) HOURS NORMAL DUTY TIME.

THE UEL CONSUMPTION WOULD BE 12 KM. PER LITRE AND MOBIL CONSUMPTION WOULD BE CALCULATED 5(FIVE) LITES PER 2500 KM. RUN.

PAY OF THE DRIVER, COST OF REPAIR, MAINTENANCE, SUPERVISING AND OTHER ALLIED COST 5 SHOULD BE BOURNE BY THE OWNER OF THE VEHICLE IN ALL CASES.
