

Comments to the Construction Methodology for FM - 18


(Submitted by Mackintosh Burn Limited)

- A brief mention in line with GCC 15.3 mentioned under PCC should be made at the beginning of the Construction Methodology.
- Construction methodology may be submitted in detail incorporating following components:
 - Methodology for Construction of Cross bundhs & sequence of taking up segment wise desiltation works including plan for bailing out water.
 - Methodology for Construction of Steel Bridge.
 - Methodology for River Bank Protection works including preparation of Sub-base for laying Geotextile and boulder.
- Baseline environmental parameters as per notes under Appendix - II/12 needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
- PER-1 & PER-2 may be freshly submitted incorporating the criteria mentioned in "Key Personnel" of Section III of bid document.


