Comments to the Construction Methodology for FM – 32


(Submitted by Udayan Co-operative Labour Contract and Construction Society Ltd.)

- A brief mention in line with GCC 15.3 mentioned under PCC should be made at the beginning of the Construction Methodology.
- Construction methodology may be submitted in detail incorporating following components:
 - Methodology for Bank Protection works including preparation of Sub-base for Cement Concrete Block pitching.
 - Methodology for Construction of Cement Concrete Road on the top of the embankment.
- Baseline environmental parameters as per notes under Appendix – II/12 needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
- PER-1 & PER-2 may be freshly submitted incorporating the criteria mentioned in “Key Personnel” of Section III of bid document.



Summary of Scope of Work:	This work consists of Flood Protection Measure and Improvement of Inspection Path of Gaighata Khal both Embankment in Block Bagnan-I & Amta II, P.S. - Bagnan and Joypur under Howrah Irrigation Division, Package - XXXII (FM-32). The main component of the work comprises of : a) Embankment improvement by various structural interventions like Riverbank protection by CC Block (M 20 nominal mix, equivalent to 1:1.5:3) for a length of 1.75Km. b) PCC (Grade M20) Road (width - 2.4 m) for a length of 11.060 Km. c) Protection works of Gaighata khal by c.c. block at R/S slope along with c/s strengthening and cement concrete road on the crest of the embankment.
