

(Submitted by Mackintosh Burn Limited)


- A brief mention in line with GCC 15.3 mentioned under PCC should be made at the beginning of the Construction Methodology.
- Construction methodology may be submitted in detail incorporating following components:
 - Methodology for River Bank Protection and strengthening works by construction of Floodwall including preparation of Sub-base for laying Geotextile and boulder.
 - Methodology for Construction of Cement Concrete Road
- Baseline environmental parameters as per notes under Appendix - II/12 needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
- PER-1 & PER-2 may be freshly submitted incorporating the criteria mentioned in "Key Personnel" of Section III of bid document.



Summary of Scope of Work:	This work consists Embankment improvement by various structural interventions like driving of sheet piles for lowering of the phreatic lines, RCC flood wall of various height (0.0 m for a length of 0.40 km., 0.3 m for a length of 0.30 km., 0.5 m for a length of 0.05 km. & capping beam for a length of 0.25 km. and Riverbank protection by black stone boulder for a length of 0.50 Km.) Reconstruction of properly designed Cement Concrete Road (3.75 m wide carriageway with 0.60 m shoulder on both sides) for a length of 19.260 km. The main component of the work comprises of Earthwork in excavation in the River bed / slope of bank, riverside protection works on the left bank of Damodar at several locations with boulder pitching, Earthwork in Excavation and Repair of Embankments, construction of sausages, Supplying and laying UV stabilized polypropylene woven geotextile, Supplying and driving Jhaw/Eucalyptus bullah piles, Supplying and filling empty cement gunny bags, Supply and placing Plain / R.C.C in substructure and Supplying and Driving MS U type / Z type MS sheet piles.
