- ssfulandsatisfactorycompletion. Illegible certificates, absence of contact details making it time consuming for verification purposes of CC issued by authorities outside the State are liable to be rejected by the BidEvaluation Committee (QEC).
- iii. CredentialCertificates(CC)ofsuccessfullycompletedworksinanyDepartment/autonomousauthorityoftheGovernment of West Bengal will be considered. CC of 100% completed works executed under any other State / CentralGovernmentMinistry/Department/NationalisedFinancialInstitutionOrganisation/Govt.Undertaking/Govt.Enterpri sesorGovernmentInstitutionsorLocalGovernmentBodies(Municipalities,ZillaParishad&PanchayatSamities

within West Bengal, will also be considered as valid PQ Credential. Such CC are to be issued by an officer/authority notbelow the rankofExecutive Engineer / Divisional Engineer /District Engineer/Project Managerofthe State/UnionGovernmentDepartments/Organisations; authorised signatories of CC for Panchayat Samities and Municipalities shall be the BDO & Executive Officers or equivalent administrative officers respectively. It is desirable to have telephone and FAX ore-mail addresses of the signatory of the CC for all offices outside West Bengal for verification purposes.

#### 5. PreQualification(PQ)eligibilitycriteria

**Note:**For cases where two contractors/bidders are participating in a e-Quotation for a particular work are such that onehappenstohaveworkedasasub-contractoroftheother,andboththecontractors/biddersPQsubmitworkcredentialof having completed the same job either wholly or partly,then in such case thePQ credentialof theprincipal contractor willbe considered while that of the sub-contractor willnot be taken into consideration fordetermining the eligibility criteria of the contractor/bidder during Technical evaluation of the Quotation. If the PQCredentials submitted by hitherto contractors/bidders are for different works, then both the PQ Credentials will beconsidered for determiningtheeligibilitycriteriaoftheindividualcontractors/bidders.

<u>GrossnotionalamountcalculatedfromCredentialCertificate(CC)ofasingleworkscontractcompletedwithinthezone</u>ofimmedi ateprecedingfivefinancialyearsonthedateofthise-NIQ,issuedinfavourofthecontractor/bidder /Agency/Firm/Registered Co-operative Society for a similar work defined in the Quotation <u>should be at least 30%</u> of theamount put to Quotation for the work it is bidding. The power to decide on the criteria of similarity rests without anyprejudice, solely with the BidEvaluation Committee (QEC).

#### 6. Additionaleligibilitycriteriaforparticipatinginmorethanoneserialofworkinae-NIQ

If the same bidder bids separately for on behalf of another Firm or in a different capacity having financial interests in thesamework, all the Quotations would be rejected.

#### 7. Penaltyforsuppression/distortionoffactsandwithdrawalof L1 bidder beforeacceptanceof LOI

If a contractor/bidder fails to physically produce the originals of documents (especially the Credential Certificates and P/L accounts with audited balance sheets), or any other bid document on demand by the Quotation Evaluation Committee (HQL) and the P/L accounts with a distribution of the P/L accounts with a distributEC/QEC) which were submitted as soft copies in PDF files with theire-bids within a specified time frame, need arising due to soft material deviations detected in the uploaded copies, leading to specific any which could not be cleared by enquiry from issuing authority of these documents or if there is any suppression / distortion / falsifica tion noticed/detected/ pointed out at any stage of the e-Quotation process at any stageprior to signing of Contract-Agreement or the issue of LOA or AOC, the Quotation Inviting Authority will immediately bring the matter to the notice of the concerned Chief Engineer and appropriate penal measures as stated in Clause 10below will be taken. The concerned then will issue the necessary order in writing with thedefaultingcontractor/bidder,otherChiefEngineers,Centralizede-QuotationCellandalsotheGovernmentintheIrrigation & Waterways Department. Copy of the order/starting penal measures should invariably be communicated tothe Nodal Officer, e-Governance Cell of the Department with a request for uploading the order in the Departmentalwebsitein thelink"Listofsuspended/debarredcontractors".

#### 8. PROCEDUREFORSUSPENSIONANDDEBARMENTOFSUPPLIERS/CONTRACTORS

#### A. SCOPE:

The procedures laid down in subsequent paragraphs shall govern the suspension and debarment of suppliers, contractors and bidders ("Contractors" for brevity) involved in Government procurement for offenses or violations committed during competitive bidding and contract implementation, or even later for the works under Irrigation & Waterways Department, Government of West Bengal. The concerned Chief Engineer shall publish the suspension and debarment order in the Departmental website with the approval of I&W Department the designated link within 1 (one) working day of issuance of such order. The TIA shall recommend the case to HQEC/QEC who with opinion of Chief Engineer will place it before DTC/QBEC/DTTC for approval.

## B. PROHIBITIONONSUSPENDED/DEBARREDPERSONS/ENTITIESTOPARTICIPATEINTHEBIDDINGOFGOVERNMENT PROJECTS/CONTRACTSOFTHEDEPARTMENT

Aperson/entitythatissuspended/debarredbyaprocuringentityshallnotbeallowedtoparticipateinanyprocurement process under Irrigation & Waterways Department during the period of suspension / debarment unless thesamehasbeen revokedbythecompetentauthority.

A Joint Venture or Consortium which is suspended / debarred or which has suspended / debarred member/s and/orpartner/s as well as a person/entity who is a member of suspended /debarred Joint Venture or Consortium shall,likewise, not be allowed to participate in any procurement process under Irrigation & Waterways Department during theperiodofsuspension/debarmentunlessthesamehasbeen revoked.

#### C. DEFINITIONOFTERMS:-

Bid / Quotation Evaluation Committee'(QEC) for the bids upto Quotation value of Rs. 45.00 lakh (QEC) invited by the Executive Engineer will be comprising of i) Concerned Executive Engineer as Chairperson and Convener, ii) Assistant Engineer concerned to the work as Member, iii) Another Assistant Engineer from Division as Member or the Junior Engineer posted as the Divisional Estimator.
- $b. \hspace{0.5cm} or, Evaluation Committee constituted by the Department from time to time. \\$
- iii. Consolidated Debarment List: A list prepared by the Departmental Debarment Committee/Chief Engineer containingthe list of bidders debarred by the Irrigation & Waterways Department, Government of West Bengal. The list would
  - bedisplayed prominently in the designated link in website of the Department clearly stating the period of suspension/debarment.
- $iv. \quad Contract implementation: A process of undertaking a project in accordance with the contract/Agreement documents. \\$
- v. **Debarment:** An administrative penalty, in addition to the contract/Agreement provisions, disqualifying a bidder fromparticipating in any procurement process under Irrigation & Waterways Department, Government of West Bengal for agiven period.
- vi. **Debarred Bidder:** A Bidder who was disqualified by the competent authority of the Irrigation & Waterways Department, Government of WestBengal.
- vii. Department:Irrigation&WaterwaysDepartment,GovernmentofWestBengal

- ix. Offence: A violation or breach of the Constitution of India, laws, regulations, laid down procedure, etc under Prevention of Corruption Act, 1988, Code of Criminal Procedure, 1973 u/s 195(1) and Section 197(1), Competition Act, 2007 and ITAct. 2000 as amended.
- **x. Procurement:** It is the act of buying goods, services or works from an external source. It is favourable the goods, servicesor works are appropriate and that they are procured at the best possible cost to meet the needs of the acquirer in termsofqualityandquantity, time and location.
- xi. **Procuring Entity/Authority:** The officer authorised by the Irrigation & Waterways Department, Government of WestBengalfor procurement.
- **xii. Suspension:**TemporarydisqualificationofabidderfromparticipatingintheprocurementprocessofIrrigation&WaterwaysDep artment for aperiod of6(six)monthswhenanoffenceismadeagainstabidder.

#### D GROUNDSFORSUSPENSIONANDDEBARMENT

- i. Submissionofeligibilityrequirementscontainingfalseinformationorfalsifieddocuments.
- ii. SubmissionofBidsthatcontainfalseinformationorfalsifieddocuments,ortheconcealmentofsuchinformationintheBidsin ordertoinfluencetheoutcomeof eligibilityscreening or any otherstageofthe bidding process.
- iii. Unauthoriseduseofone'sname/digitalsignaturecertifiedforpurposeofbiddingprocess.
- iv. Anydocumentedunsolicitedattemptbyabiddertoundulyinfluencetheoutcomeofthebiddinginhisfavour.
- v. All other acts that tend to defeat the purpose of the competitive bidding such as lodging false complaints about any bidder, posting baseless allegation about any officer duly authorised by the Department, restraining any interested bidder toparticipate in the bidding processetc.
- vi. Refusal to accept an award after issuance of 'Letter of Acceptance' or enter into contract with the Government without justifiable cause.
- vii. Refusalorfailuretoposttherequiredperformancesecurity/earnestmoneywithintheprescribedtimewithoutjustifiablecause.
- viii. Subcontractingofthecontractoranypartthereofwithoutpriorwrittenapprovaloftheprocuringentity.
- ix. Failure solely due to fault or negligence of the Contractor, to mobilize and start work within the specified period asmentioned in the 'Letter of Acceptance' / 'Letter of Acceptance cum work Order' / 'Work Order' / 'Notice of Process' /'Award of Contract'etc.ultimately resulting in rescindment of contract.
- x. Failure to fully and faithfully comply with the contractual obligations without valid cause, or failure to comply with anywritten lawful instruction of the procuring entity or his representative(s) pursuant to the implementation of the contract,ultimatelyresultinginrescindment of contract.
- xi. For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier ordistributor arising from his fault or negligence and / or unsatisfactory or inferior quality of goods, vis a viaas laid downinthecontract.
- xii. Refusal or failure to upload a self-declaration in specimen format of Form-4 to the effect of any previous debarmentimposed by I&WD, any other Department of State Government and or Central Government.

#### E. CATEGORYOFOFFENSE:

Period ofdebarment will be 2 times the corresponding period penalty applicable for 1st degree offence in addition to other penalprovisionscontainedin1st degreeoffence.

Debarment procedure and rules are published as Departmental Notification to be read in conjunction with the Corrigendaissuedfrom time totime, as may be seen in the Notification link of the Departmental website wbiwd.gov.in

#### G. PENALTYFOROFFENSE:

a. For committing 1st degree offense any of the cases referred under Clause 9 D (i) to (v), forfeiture of earnest money anddebarment for a period of six months, if the offense is detected during technical evaluation. If the offence is detected afteraward of the contract and if the offender happens to be the agency selected for work, and such selection is made due tooversight, forthwith termination of the contract and determination of contract value in accordance with clause 3(ix) (c) of WestBengalFormNo.2911, and simultaneous debarment for aperiod of six months. Further, in case the offense is detected after completion of work and payment of final bill the Work credential earned would be declared as 'null andvoid', so that the same cannot be used in future as PQ credential for securing other works contracts in the Irrigation & Waterways Department, together with debarment for aperiod of six months.

- b. For committing 1st degree offense in any of the cases referred under Clause 9 D (vi), (vii), (xiii) to (xv), forfeiture ofearnest money and debarment for a period of one year. For committing offenses under Clause 9D (xv), debarment periodshall be for one calendar year preferably from the date on which the due date for submission of BG had expired (i.e 8th or15thworking day from date of receipt of LOA /LOI) by the concerned Chief Engineer to be notified in the Departmentalwebsite.
- c. For committing 1st degree offense in any of the other cases under Clause 9 D (viii) to (xii), termination of contract and itsdeterminationinaccordancewithClauses2&3ofWestBengalFormNo.2911,includingdebarmentforaperiodoftwoyears.
- d. For committing 2<sup>nd</sup> degree offenses under above all categories, period of debarment will be twice the corresponding periodfor1<sup>st</sup>degreeoffenses,inaddition tootherpenal provisionsfor1<sup>st</sup>degree offense.

#### 9. Taxes &dutiestobeborne bythe Contractor/bidder

In view of introduction of GST witheffectfrom 01.7.2017, all the bidders intendingtoparticipate in thise-QuotationshouldoffertheirfinancialbidsinclusiveofGSTapplicableforentirecompositeworks/Procurementofgoods&service s,labour intensive component contained in the BOQ.Income Tax, Royalty, GST (CGST,SGST, IGST),Construction Workers'Welfare Cess, Labour InsurancesEPF and similar other statutory levy /cesswillhave to be borne by the contractor/bidder and his/her quoted rate should be quoted accordingly after considering allthese charges, and no separate payment towards any of the statutory taxes rents or levies shall be made by the workimplementingauthority.

#### 10. SiteinspectionpriortosubmissionofQuotation

Before submitting ae-Quotation, theintendingcontractor/bidder should make themselvesacquainted thoroughlywiththe local conditions prevailing at site of implementation of the work by undertaking field inspections and taking intoconsideration all probable factors and difficulties to be involved during execution of the work as per specification in allrespectsincluding transportation materials, communication facilities, climateconditions, nature of soil, availability of local labourers and market rates prevailing in the locality etc. and noclaim whatsoever will be entertained on thoseaccounts afterwards. The contractor/bidder may also contact the office of the designated Assistant Engineer/ExecutiveEngineer, Jalpaiguri Irrigation Division in between 11.30 hours to 16.30 hours on any working day, prior to the date oflastdatefor submission of bidinthee-Quotation.

#### 11. ConditionalandincompleteQuotation

Conditional and incomplete Quotations are liable to be summary rejected. No off-line document will be entertained untilcompletionofe-

Quotation process by way of acceptance of L1 bid by the competent Quotation Accepting Authority/Government.

Notices for open off-line Quotations foreachQuotationvaluebelowRs5.00lakhshallincludesuchclausesasisnotifiedbytheDepartmentfromtimeto time.

Fore-Quotations bidsareto beinvitedintwopartsunderatwo-bidelectronicsystem.

- i. Technical proposal will be opened by the Quotation Inviting Authority or his/her authorised representative/selectronically in the eofficial website using their authorised valid Digital Signature Certificate/s(DSC).
- ii. Intendingcontractors/biddersmayremainpresent iftheysodesire.
- **iii.** Technical cover documents(videClause3.2.A)willbe opened /decryptedfirstandiffoundin order, Cover(Folder)forOID(videClause3.2.B)willbeopened/ decrypted.If there is any material deficiency in either of theTechnicalcoverdocuments,thee-bidisliabletobe disqualified&rejected.
- iv. Decrypted(transformed into readable format) documents of the Pre-Qual Technical cover and the OID (Other ImportantDocument)Coverwillbedecrypted/downloadedbytheTIAandhandedovertotheTechnicalBidEvaluationCommitte e(QEC).

#### ${\bf 13.2} \quad Process of Technical Evaluation in a Quotation$

Within 24 hours of uploading the TBO summery sheet containing Preliminary Technical Qualification result, any of theaggrieved bidder, may seek clarification / redressal / review from the QEC on the list of bidders, in writing/through e-mailwithsupportingfacts/figures/documents.Ifsuchclarification/reviewrelatestoeligibilityofotherbidders,onthe grounds of submission of false/ forged / manipulated / inappropriate credentials, modalities prescribed in theDepartmentalNotificationshallbefollowed.Incase,thereviewonlyseekstheeligibilityoftheapplicanthimself,viewsoftheQu otationEvaluationCommittee(QEC)wouldbecommunicatedinwritingtothatbidderwithinnexttwo(2)

working days. If the bidder is not satisfied with the clarification of the QEC, he/she may appeal to the concerned ChiefEngineer within 24 hours of receipt of communication from the QEC. The concerned Chief Engineer will dispose suchcomplaints jointly, in associated with at least another available Chief Engineer within next 2 working days. ThereafterfinalTechnicalEvaluation Sheet (TBE)oftheTechnicallyqualifiedbidderswould be uploaded, after incorporatingmodifications if required. The TIA shall while uploading the final TBE summery sheet accept or reject electronically theadmittedbidsbased on the advice ofQEC as perTBEsummery sheet. Thus at this stage the rejectedbidderswillgetback their EMD. e-mail communication in official e-mail address of TIA or QAA shall be treated as a valid

of communication. The minimum time period from date of TBO summery sheet uploading and TBE summery sheet uploading shall be 4 working days or more.

#### 13.3 UploadingthelistofTechnicallyqualifiedcontractors/bidders

- **ii.** Whileevaluating,theQECmay,iftheysodesire,summonthecontractors/biddersandseekfurtherclarification/informationors eek verifications of originalhardcopyof any of/all the documents already submittedon-line,andifthesecannotbe producedwithinstipulatedtimeframe,theirbidswill be liableforrejection.

#### 13.4 OpeningandEvaluationofFinancialProposal/bid

- i. Financialproposalsofthebidders/contractorsdeclaredTechnicallyqualifiedbytheBid/QuotationEvaluationCommittee (QEC)will be openedelectronically by the Quotation Inviting Authority in the web portal stated aboveontheprenotifieddateandtime.
- ii. The encrypted copies will be decrypted and the rates will be read out to the contractors/ bidders remaining present atthat time, else they may login their respective e-Quotation accounts to see the (CS) comparative statement in the webportal.
- **iii.** Afteropeningthefinancialproposal,thepreliminarysummaryresultcontaininginteraliathenamesofcontractors/bidders and the rates quotedby them will be uploaded and the result will be made available in the e-Quotationplatform.
- **iv.** If the Quotation Accepting Authority (QAA) issatisfiedthattherateobtainedisfairandreasonableand there is noscope offurtherloweringdownofrate, he/she mayafterhavingthecomparativestatementtestcheckedbytheDivisional Accountant / Divisional Accounts Officer attached to his office and after their acceptance upload the financialbid evaluation summarysheet or resultcontaining thename ofcontractors/bidders andtheratesquotedby themagainst eachwork.
- v. If there is any scope for lowering down ofrate in the opinion of the Quotation Accepting Authority being abnormallyhigh, i. e above 10% of the amount put to Quotation (Quotation value), the e-NIQ shall be cancelled and invited afresh 2<sup>nd</sup>or3<sup>rd</sup>re-Quotation. NopostQuotationnegotiationsarepermitted.
- **vi.** If there is any scope for lowering downofrate in the opinion of the Quotation Accepting Authority being abnormally high above 10% of the amount put to Quotation i.e Quotation value, the e-NIQ shall be cancelled and invited afresh. NopostQuotationnegotiationispermitted.
- vii. If there is no contractor/bidder or the number of contractors / bidders in the 1stQuotation is less than three, the e-Quotation has to be cancelled. #### 13.5 QuotationAcceptingAuthority(QAA)

Authority to which the power has been delegated to accept Quotations as per latest Finance Department Notification willfunction as the Quotation Accepting Authority (QAA) for evaluation of Technical and financial proposals of works havingQuotationvalue withinhis/her range ofacceptance.

As per present delegation, QAA for different Quotations within the range above Rs 1 Lakh upto Rs 100.00 Lakh would beasfollows:

- i. For e-Quotations of value up to Rs 100.0 lakh (above Rs 5.00 lakh and up to Rs 100.0 lakh): Executive- Engineer, Kangsabati Canals Division No.-II,I&WDirectorate.
- **ii.** For off-line Quotations of value from Rs 3.0 Lakh up to Rs 5.0 Lakh is to be Quotation in a single bid system in off-line modetobeacceptedbyExecutiveEngineer,Kangsabati CanalsDivision No.-II,I&WDirectorate. [off-linesinglebidQuotations]
- iii. For Quotations of value up to Rs 1.0 Lakh relating to works only, is to be Quotation in a single bid system in off-line modeto be accepted by Assistant Engineer under Kangsabati CanalsDivision No.-II, I&W Directorate. [Off-line single bid systemManual Quotations] on the basis of Technically sanctioned costs.

#### 13.6 Proceduretobefollowed forfinal acceptance of Quotation & Award of Contract

- i. The lowest (L1) financial bid for all works Quotations is accepted as a rule. If for any reason the lowest (L1) bid is notaccepted, reference is to be made to the appropriate Government for orders as to which of the contractor /bidder theworkshouldbeawarded.
- ii.
