  - v) Certificate of registration ( in the case of firms and Registered Co-Operative Societies)
  - vi) Partnership Deed (in the case of Partnership Firm).
  - vii) Declaration by the applicant to the effect that there is no other application for tender paper for work in this NIT in which he/she/they has/have common interests.
  - viii) Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, valid up to the date of opening of the tenders
  - ix) Originals of all the above documents together with Bye-laws & Eligibility Certificate are to be produced at the time of interview, if any.
  - x) Failure to produce anyof the above documents may be considered good and sufficient reason for non-issuance oftender paper.
- The "Additional Perfrmance Security" shall be obtained from the successful L1 bider if the accepted bid value is below 20% of the estimated amount put to tender. This Additional Performance Security shall be equal to 10% of the tendered amount i.e the L1 bid price.
- Failure to attend the interview, if any, either in person or through a duly authorized person will debar the applicant from accepting the tender form. 6
- Tender forms will be issued only to applicant himself or his duly authorized agent on personal appearance. 7
- Each tenderer will have to deposit an earnest money of the amount specified against each work in any of the following forms.
- 9 (A) Mode of Payment :- Cost towards Earnest Money Deposit (EMD) must be submitted in the form of Bank Draft (BD) / Bankers Cheque (BC) / Deposit Call Receipt (DCR) of any scheduled Commercial Bank in India approved by RBI & having a branch in West Bengal which is to be drawn in favour of the Executive Engineer, Alipurduar Irrigation Division, I & W Dte., payable at Alipurduar.
- (B) Payment in any other forms viz. NSC, KVP etc. will not be accepted.
- C) Opening of Tenders:-

- Tenders will always be placed in SEALED COVER and the name of contractor / Agency, Sl. No. of work with N.I.T. No. must be written on the sealed cover 15

- Before submitting any Tender, the intending Tenderers should make themselves acquainted thoroughly with the local conditions prevailing by actual inspection of the site and take into considerations all factors and difficulties likely to be involved in execution of the work in all respects including transportations of materials, 17 communication facilities, climate conditions, nature of soil, availability of local labourers and market rate prevailing in the locality etc. as no claim whatsoever will
- Consumption of material will be calculated on the basis of schedule of rate of Unified Schedule of Rates (USOR), I & W. Dte./Public Works Department, West Bengal. This notice, additional terms and conditions and general specification of works with mode of measurement as per printed schedule of rate of Unified 18 Schedule of Rates (USOR), I & W. Dte./Public Works Department, West Bengal.
- No claim will be entertained for any increase in railway freight, cost of P.O.L and market price of the materials and labour rates. 19
- In the event of (I) tender paper issued but not purchased or (II) tender paper purchased but not dropped i.e. not participated, will be taken into account seriously 20 in issuing tender forms in future
- Any suppression/misrepresentation of fact will automatically debar the applicant from participating in any Tender under the Division/Circle for at least 3 (three) 21 years from the date of detection, in addition to such other panel action as the Government may deem proper.
- Intending tenderer not satisfied with the decision of the tender paper issuing authority may prefer an appeal to the next superior officer. Concerned Chief 22 Engineer will be the Appellate Authority for High Value Tenders. Necessary communication regarding his appeal to the appellate authority must be brought to the notice of such Authority within two working days after the date of issue of tender paper and copy of such communication should also be submitted to the Tender Paper Issuing Authority within the same period, failing which no such appeal will be entertained.
- Tenders with over writing or illegible writing are liable to rejection. Any correction should invariably be signed by the tenderer. 23
- When tenderer signs his tender in any Indian Language the total amount tendered for should also be written in the same language. In case of illiterate tenderer 24 the rates of tenderers are to be attested by a witness. In the event of a tender submitted by a partnership firm, it must be signed by each of the partner of the firm or a person holding power of attorney as stipulated in the Indian Partnership Act.
- Tender will be opened at the above scheduled place and time in presence of such of the tenders of their duly authorized agents who may be present at the time 25 of opening of the tenders.
- The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without 26 assigning any reason whatsoever to the intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers.
- The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him. 27
- 28 Any letter or other instrument submitted separately in modification of the sealed tender will not be entertained.
- 29 Conditional Tender, which does not fulfil any of the above conditions, and is incomplete if any respect, is liable to summary rejection.
- Authority to issue tender forms for works other than once applied for is reserved by the Sub Divisional Officer, Kamakhyaguri Irrigation Sub Division. 30
- The successful Tenderer will have to execute the duplicate/triplicate/quadruplicate copies of his tender which will have to be obtained free of cost from the office 31 of the Sub Divisional Officer, Kamakhyaguri Irrigation Sub Division within7 (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
- If any Tenderer withdraws his tender before its acceptance or refuses/fails to convert it into a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal/refusal/failure, he shall be disqualified for submitting any Tender in this Sub Division for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- 33 The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due to delay in payment will be entertained.
- GST, Royalty, Building & other Construction Workers' Cess and all other statutory Levy/Cess etc. will have to be borne by the Confractor (he will have to produce 34 necessary documentary evidence of his having done so at the time of receiving the final payment for the work). All taxes etc. will be charged and/or deducted as per rules and laws of the country as applicable.
- The tenderer should have own modes of communication. 35
- In case of settlement of any dispute, the matter may be referred to the Departmental Dispute Redressal Committee formed by Government. This provision will be 36 applicable irrespective of the value of the works to which the dispute may relate.
