In reference to the Memo No. 152 dated. 05.07.2023 of the SDO-II/RRI/HCL and in pursuance of the Executive Engineer (SDP)'s Memo No. 432 dated 05.07.2023, Sealed tenders/bids from intending bidders are invited in prescribed format for auction sale of fruit bearing and cotton trees for the two consecutive years 2024 and 2025 (for two years only)" at River Research Institute, Mohanpur, Nadia. The tender/bid application along with terms and conditions and detail list of the said fruit bearing trees put under auction sale with reserve price are being enclosed. The bid will be opened at Executive office at RRI/HCL/on date: 29/09/2023 at 3.00P.M.

The following terms and conditions will be maintained by the bidders:-

- 1) The Executive Engineer has every right to accept or cancel the auction.
- 2) At the time of bidding an application has to be submitted by the participants.
- 3) Bidders are advised to inspect the property under Auction Sale and satisfy themselves regarding the nature, description, condition, encumbrance, lien, charge, statutory dues, etc over the property before submitting their bids.
- 4) Property can be inspected on any date (except public holidays) between 21.09.2023 to 27.09.2023 with prior intimation to the office.
- 5) Bids in the prescribed format (Annexure-I) along with Item Description for Auction in Annexure-II shall be submitted by the Bidder. Bids submitted otherwise shall not be eligible for consideration and shall be rejected.
- 6) Bids shall be submitted before the last date and time given in the sale notice.
- 7) Bids form shall be duly filled in with all the relevant details and signed at each page by the bidder.
- 8) Incomplete/unsigned bids without EMD will be summarily rejected.
- 9) The bidder must be submitted GST registration certificate, Trade License, Pan Card and Aadhar Card (Self attested) along with the bid form.
- 10) The Reserve Price (upset price) of these fruits bearing and cotton trees under auction has been fixed at Rs.1,88,200/-
- 11) The bid shall be accompanied by the EMD amount of Rs.18,820/-
- 12) EMD in shape Draft/Demand Draft shall be madeein favour of the Executive Engineer, SDP, RRI, HCL payable at Kalyani Treasury.
- 13) Bid form without EMD and below the reserve price / upset price shall be summarily rejected.
- 14) No bid will be allowed below the reserve value.
- 15) The highest bidder will have to deposit the quoted amount in full and single instalment within seven (07) days of acceptance of the action and amount to be deposited in shape Draft/Demand Draft in favour of the Executive Engineer, SDP, RRI, HCL payable at Kalyani Treasury.
- 16) Failure to deposit the money would cancel his auction, and the bid participants money deposited would be forfeited.
- 17) The department would bear no liability for any damage/loss being caused by natural calamity theft/Virus attack /breaking down of any branches of tree.

- 18) Successful bidder would be allowed to look after the trees for treatment, guarding, and taking out the fruits from the RRI campus.
- 19) Guarding will have to be done at his own cost and department would not bear the cost of the same after opening of the bid.
- 20) Dispute if any, are to be settled primarily by the sub-divisional officer no-II and then if necessary, action, by the Executive Engineer (SDP) RRI.
- 21) Bid participant money deposited would be treated as deposited against any damage being caused of the trees by the contractor or his men and same will be refunded only after successful completion of the job subject to above mentioned condition.
- 22) If the last date in respect the receiving the auction is declared as holiday auction will be held on the next working day.
- 23) EMD of unsuccessful bidders will be returned.
